RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of June 3, 2021 ("Effective Date") by SILICON VALLEY BANK, a California Corporation ("Bank") in favor of LEGEND3D, INC., a California Corporation ("Company")

WHEREAS, Company and Bank are parties to that certain INTELLECTUAL PROPERTY SECURITY AGREEMENT ("Security Agreement," attached hereto in Appendix 1), dated as of December 29, 2014, in which the Company, to secure certain advances of money and certain financial accommodations made by Bank as detailed in a "Loan Agreement" (defined in the Security Agreement), granted to the Bank a security interest in certain "Intellectual Property Collateral" (defined in the Security Agreement).

WHEREAS, the Security Agreement was recorded at least in the United States Patent and Trademark Office ("USPTO") on January 5, 2015 at Reel/Frame 034637 / 0193 - 0217;

WHEREAS, Company's obligations to Bank have now been satisfied in their entirety, including under the Loan Agreement, and Company and Bank now desire that any and all of Bank's security interests in and to any and all of the Intellectual Property Collateral be terminated and released in its entirety, and that evidence of such termination and release be reflected in this signed writing, recordable with appropriate authorities to reflect the same;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank, without further representation, warranty or recourse, hereby terminates and releases its entire security interest in and to any and all of the Intellectual Property Collateral.


The Bank acknowledges that this document may be filed with the USPTO, the United States Copyright Office, and any other appropriate domestic and foreign authorities as Company may desire, to evidence the termination and release provided herein.
