1. The name of the corporation is Hyperfine Research, Inc. (the "Corporation"). The date of filing of the original Certificate of Incorporation of the Corporation with the Secretary of State of the State of Delaware was February 25, 2014. Amended and Restated Certificates of Incorporation of the Corporation were filed with the Secretary of the State of Delaware on February 27, 2014 and January 17, 2017, a Certificate of Amendment was filed thereafter on June 23, 2017, an Amended and Restated Certificate of Incorporation of the Corporation was filed on October 9, 2020, a Certificate of Amendment was filed thereafter on October 23, 2020, a Certificate of Amendment was filed thereafter on December 9, 2020, and a Certificate of Amendment was filed thereafter on December 22, 2020 (for purposes of this Amended and Restated Certificate of Incorporation, the "Restated Certificate of Incorporation").

2. The Restated Certificate of Incorporation is hereby amended by deleting in its entirety Article FIRST thereof and replacing it with the following new Article FIRST:

"FIRST: The name of the corporation (hereinafter called the "Corporation") is

HYPERFINE, INC."

3. The amendment of the Restated Certificate of Incorporation herein certified has been duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
