RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of June 9, 2021, by California Bank of Commerce, a California corporation ("Lender"), in favor of CLEO COMMUNICATIONS, INC., an Illinois corporation ("CCI"), STREEM COMMUNICATIONS LLC, an Illinois limited liability company ("Stroom"), CLEO COMMUNICATIONS HOLDING, LLC, a Delaware limited liability company ("Holdco"), EXTOL INTERNATIONAL, INC., a Delaware corporation ("Extol"), and CLEO COMMUNICATIONS US, LLC, a Delaware limited liability company ("CCUS"). CCI, Stroom, Holdco, Extol, and CCUS are collectively referred to herein as the "Grantors".

Recitals

WHEREAS, Grantors granted to Lender a security interest in the intellectual property of Grantors, including without limitation the copyright, patent and trademark items listed on Exhibits A, B and C attached hereto, respectively (collectively, the "Intellectual Property"), under an Intellectual Property Security Agreement dated as of April 30, 2020 (the "Security Agreement") which was recorded with the US Patent and Trademark Office and the US Copyright Office as set forth on Exhibits A, B and C respectively.

WHEREAS, Grantors have no outstanding obligations to Lender under the terms of the Security Agreement, Lender agrees to terminate and release its security interest in the Intellectual Property.

Agreement

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Lender hereby terminates the Security Agreement, including all of Lender's rights provided for therein, and Lender hereby terminates, discharges, and releases all of its security interest in the Intellectual Property, including without limitation all proceeds thereof, and assigns, transfers and conveys to Grantors, without warranty or recourse, any interest of Lender in the Intellectual Property and any proceeds thereof.
