RELEASE OF SECURITY INTEREST IN PATENTS

This RELEASE OF SECURITY INTEREST IN PATENTS (this “Release”), dated as of July 1, 2021 (the “Effective Date”), is made by PNC Bank, National Association, as collateral agent (the “Agent”) in favor of PRA HEALTH SCIENCES, INC. (the “Grantor”). All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed to them in the Patent Security Agreement (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain Security Agreement, dated as of October 28, 2019 among the Grantor, the Agent, and the other parties thereto (as may have been amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantor executed and delivered that certain Grant of Security Interest in Patent Rights, dated as of October 28, 2019 (the “Patent Security Agreement”), which was recorded in the United States Patent and Trademark Office (“USPTO”) on November 1, 2019 at Reel/Frame 050890/0571;

WHEREAS, pursuant to the Security Agreement and the Patent Security Agreement, the Grantor granted a lien on and security interest in (the “Security Interest”) all of the Grantor’s right, title and interest in, to and under the Patents (including, without limitation, those items listed on Schedule A hereto), and all rights, priorities and privileges related thereto and all rights to sue at law or in equity of otherwise recover for any past, present or future infringement, misappropriation, dilution or other violation thereof, including the right to receive all proceeds therefrom (collectively, the “Patent Collateral”); and

WHEREAS, the Agent and the Grantor acknowledge that the requirements for releasing the Security Interest in the Patent Collateral have been met.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, hereby (a) terminates and cancels the Patent Security Agreement, (b) releases, discharges, terminates and cancels the Security Interest in the Patent Collateral, and (c) re-assigns to the Grantor any right, title or interest it may have in the Patent Collateral, in each case without recourse to the Agent and without representation or warranty of any kind.


