NOTICE OF GRANT OF SECURITY INTEREST IN UNITED STATES PATENTS

This NOTICE OF GRANT OF SECURITY INTEREST IN UNITED STATES PATENTS (this "Notice"), dated as of May 15, 2021, is entered into by CASSANDRA LIMITED, a company incorporated on Guernsey (the "Grantor"), in favor of MATIAS EMILIO ROJAS, a natural person (the "Security Agent"). Unless otherwise defined herein or the context otherwise requires, terms used in this Notice have the meanings provided or provided by reference in the Security Agreement (as hereinafter defined).

WHEREAS, the Grantor is party to a Security Agreement, dated as of the date hereof (the "Security Agreement") in favor of the Security Agent pursuant to which the Grantor pledged and granted to the Security Agent, a security interest in and to certain of its Intellectual Property ("the "Security Interest");

WHEREAS, such Security Interest includes such Grantor's Patents set forth on Schedule A hereto (such scheduled Patents, the "Patent Collateral"); and

WHEREAS, the Grantor has duly authorized the execution, delivery and performance of this Notice;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and subject to the terms and conditions of the Security Agreement, the Grantor hereby pledges to the Security Agent as collateral security, and grants to the Security Agent a security interest in, to and under (i) the Patent Collateral and (ii) all rights and claims of such Grantor to any proceeds of such Patent Collateral.




