application is filed, as may be applicable; together with the entire right, title and interest in, to and under all continuations, continuations-in-part, divisions, renewals, reissues, reexaminations and extensions of all forms of industrial property protection, including, without limitation, patents, utility models, inventors' certificates and designs defined above; to have and to hold for sole and exclusive use and benefit of the Assignee, its successors and assigns, to the full end of the term or terms for all such patents.

The Assignor hereby covenants and agrees, for both the Assignor and the Assignor's legal representative, that Assignor has the full right to convey the entire right, title and interest assigned by this Assignment, that such right, title and interest is unencumbered, and that the Assignor has not executed, and will not execute, any agreement in conflict herewith; and that the Assignor will assist the Assignee in the prosecution of the patent applications identified above, in the making and prosecution of any other applications that the Assignee may elect to make covering the invention identified above, in vesting in the Assignee like exclusive title in and to all such other patent applications and patents, in the prosecution of any interference which may arise involving said invention, or any such patent application or patent, and in assisting Assignee in enforcement of any rights arising out of this Assignment; and that the Assignor will execute and deliver to the Assignee any and all powers of attorney, applications, assignments, declarations, affidavits and any other additional papers which may be requested by the Assignee, its successors, legal representatives and assigns to carry out the terms of this Agreement.

The Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, is hereby authorized and requested to issue the same to the Assignee, its successors, legal representatives and assigns, in accordance with the terms of this Assignment.


