PATENT RELEASE

THIS PATENT RELEASE is made as of July 1, 2021, by ANTARES CAPITAL LP, in its capacity as administrative agent for itself and the other Credit Parties (“Agent”). WHEREAS, BACHARACH, INC., a Delaware corporation (“Grantor”) and Agent were parties to a First Lien Pledge and Security Agreement dated August 24, 2017 and that certain Notice of Grant of a Security Interest – Patents, dated as of August 24, 2017 (the “Security Agreement”), pursuant to which Grantor granted a continuing security interest to Agent in certain patents (“Patents”) and Patent Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including certain of the patents set forth on Schedule I hereto;

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office (“USPTO”) on August 24, 2017 at Reel 043391, Frame 0414; and


NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged by the parties to the Security Agreement:

1. Agent hereby terminates the Security Agreement and terminates and releases its security interest and all of its right, title and interest in, to, and under the Patents, including, among other things, the goodwill of the business symbolized by Patents owned by Grantor, including those set forth on Schedule I hereto (collectively the “Patent Collateral”).
2. Agent hereby releases, grants and conveys to Grantor, any and all of Agent’s right, title and interest in and to the Patents and Patent Collateral.
3. Agent hereby authorizes the recordation of this Release with the USPTO or any similar office or agency within or outside the United States at Grantors’ expense. Agent further authorizes and requests that the Commissioner for Patents and any other applicable government officer record this Release.
4. Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.
5. This Release shall be governed by and construed in accordance with the laws of the State of New York.
