TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS**, dated as of July 1, 2021 ("Release"), is made by AEA Mezzanine Fund IV LP, as Collateral Agent ("Collateral Agent") in favor of Bacharach, Inc., a Delaware corporation ("Grantor").

WHEREAS, pursuant to that certain Second Lien Pledge and Security Agreement dated as of July 3, 2018 (as amended, restated, amended and restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement") by and among the Grantor, Collateral Agent, and others party thereto, and the Notice of Grant of a Security Interest – Patents dated as of July 3, 2018 by and among the Grantor and Collateral Agent ("Patent Notice"), Grantor granted to the Collateral Agent, for the benefit of the Credit Parties, a continuing security interest in all right, title and interest of Grantor in, to, and under all Collateral (as defined in the Patent Notice); and

WHEREAS, the Patent Notice was recorded at the United States Patent and Trademark Office ("USPTO") on July 31, 2018 at Reel 046682 Frame 0340.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of the Credit Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Patent Notice.

SECTION 2. Termination and Release. Collateral Agent, on behalf of the Credit Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in all right, title and interest of Grantor in, to, and under all Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Patent Notice; and

(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Collateral Agent, on behalf of the Credit Parties, has caused this Termination and Release of Security Interest in Patents to be duly executed as of the date first set forth above.
