INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (the "Assignment Agreement") is hereby entered into on April 7, 2021 (the "Effective Date"), by and between

Christine Koth, a citizen of the United States of America, passport No. 489712581, residence address: 3323 Withersed lane, Walnut Creek, CA 94598, United States of America (the "Assignor") of the one part; AND

ALETHA INC., a corporation organized and existing under the laws of the State of Delaware, USA, with principal offices located at 2872 Ygnacio Valley Rd. #605, Walnut Creek, CA 94598, United States of America, legally represented by Christine Koth as its CEO (the "Assignee") of the other part.

The Assignor and the Assignee are hereinafter referred to, individually, as "Party" and collectively, as "Parties".

WHEREAS, the Assignor is the proprietor and beneficial owner of each of the patent(s) and patent application(s) (the "Patents"), as well as the trademark(s) and trademark application(s) (the "Trademarks"), the Patents and Trademarks hereinafter collectively referred to as the "Intellectual Property", of which the particulars are set forth in Exhibit A, and

WHEREAS, the Assignee desires to acquire from the Assignor the Intellectual Property in accordance with the terms and conditions of this Assignment Agreement.

NOW THEREFORE, the Parties hereto agree as follows:

1. The Assignor, for good and valuable consideration, the receipt of which is hereby acknowledged, hereby assigns to Assignee, its successors, legal representatives and assigns, all right, title, and interest Assignor may have in and to the Patents, and all divisions, reissues, reexaminations, renewals and continuations thereof, and all patents which have been or may be granted thereon anywhere in the world, and all reissues and extensions thereof, and all rights of priority under International Conventions, and all applications for patents which have been or may hereafter be filed from the Patents in any country foreign to the United States, and all patents which have been or may be granted for said Patents in any country foreign to the United States, and all extensions, renewals and reissues thereof; and Assignor hereby authorizes and requests, to the extent of any right Assignor may have to do so, the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all patents for said Patents to the said Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

2. The Assignor, for the consideration referenced above, does hereby agree that she and her executors and legal representatives will make, execute and deliver any and all other instruments in writing including any and all further application papers, affidavits, assignments and other documents, and will communicate to said Assignee, its successors and representatives, all facts known to Assignor relating to said Patents and will testify in all legal proceedings and generally do all things which may be necessary or desirable more effectually to secure to and vest in said Assignee, its successors or assigns, the entire right, title and interest in and to the Patents hereby assigned or intended so to be.

3. The Assignor, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby convey, transfer and assign to Assignee, and Assignee hereby accepts the conveyance, transfer and assignment of all right, title and interest of Assignor in, to and under the Trademarks, including brands, services, logos, and goodwill represented thereby.

4. The Assignor represents and warrants that it is the sole proprietor of all rights, title, and interests derived from and in connection with the Intellectual Property, and that the assignment of the Intellectual Property from the Assignor to the Assignee shall not cause any infringement of intellectual property rights of any third party.

The Intellectual Property is assigned in their present legal status, which is known to the Assignor, to the Assignor's best knowledge, there are no parties who are using the Intellectual Property, own grants or registrations or pending applications for Intellectual Property and there are no pending cases before the court or national authorities, which may adversely affect the Intellectual Property.

5. The Assignor shall furnish the Assignee with all necessary information on and in connection with the Intellectual Property, which may be required to perfect title in the Intellectual Property in the Assignee.

6. This Assignment Agreement shall come into effect on the Effective Date of this Assignment Agreement. Each Party agrees to fully cooperate with the other with regard to such registration or additional or approval that may be required in connection with the implementation of any portion of this Assignment Agreement.

7. This Assignment Agreement may be executed in multiple counterparts, each of which shall be deemed an original hereof, and all of which shall constitute a single agreement effective as of the date hereof. Any delivery of an executed counterpart of this Assignment Agreement by facsimile or electronic mail shall be as effective as delivery of a manually executed counterpart of this Assignment Agreement.

8. Any amendments, modifications, alternations or supplements to this Assignment Agreement shall be made in writing to be legally effective.

9. This Assignment Agreement shall be binding upon and shall inure to the benefit of the parties and their respective successors and assigns.

10. This Assignment Agreement shall be governed by and construed in accordance with federal bankruptcy law, to the extent applicable, and, where state law is implicated, the internal laws of the State of California, without giving effect to any principles of conflicts of law.




