DEED OF ASSIGNMENT

This Assignment Agreement is made on 04th day of June 2021 by and between

AND

Imaginake Play Solutions Private Limited, a company incorporated under the provisions of the Companies Act, 2013, having its registered office at 401, Jasu, Dadabhai Road, Vile Parle (W), Mumbai-400056, Maharashtra, India (hereinafter for brevity's sake referred to as the "ASSIGNEE", which expression shall include the company, its directors, successors, transferees and assigns) of the Other Part.

WHEREAS the ASSIGNORS are the lawful owners and the proprietors of US patent (hereinafter referred to as "Intellectual Property"), application for which was filed in their name in US, which application is granted and the complete details whereof is more particularly set out in Annexure-A appended hereto.

WHEREAS the ASSIGNEE is desirous of acquiring the entire rights, title and interest in and to the said Intellectual Property as more particularly mentioned in Annexure A from the ASSIGNORS to have and to hold the same in perpetuity and has accordingly approached and requested the ASSIGNORS for the same.








AND WHEREAS both parties have thus agreed that the ASSIGNORS assign and transfer all their rights in and to the said Intellectual Property in question in perpetuity in favour of the ASSIGNEE in the manner hereinafter expressed.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS:

1. In pursuance of the said request and in consideration of the sum of Rs. 100/- (Rupees One Hundred Only) paid by the ASSIGNEE to the ASSIGNORS, the receipt of which the ASSIGNORS DOTH hereby admits and acknowledges, the ASSIGNORS DOTH hereby assigns and transfers all their rights in and to the said Intellectual Property, as previously mentioned in the Annexure A appended hereto unto the ASSIGNEE TO HAVE AND TO HOLD the same in perpetuity without any hindrance of any kind whatsoever.
2. The ASSIGNORS DOTH hereby covenant with the ASSIGNEE that the ASSIGNORS have in themselves the right and absolute authority to assign and transfer the said Intellectual Property as more particularly described in Annexure A appended hereinafter in the manner aforesaid and that it shall be lawful for the ASSIGNEE from hereafter to hold, possess and enjoy and utilize the said Intellectual Property for its own use or in any manner it likes without any interruption.
3. The ASSIGNORS DOTH hereby covenant with the ASSIGNEE that the ASSIGNORS have the true and absolute right and are the lawful owners of the said Intellectual Property as appended in the Annexure and the ASSIGNORS have not created any third party rights nor are there any liabilities of any kind from any party against the ASSIGNORS subsisting in the said business in question at the date of these presents.
4. The ASSIGNORS DOTH covenant with the ASSIGNEE that since the assignment is with the goodwill of the business in the said Intellectual Property, the ASSIGNORS henceforth ceases to use the same as the owner thereof and would assist the ASSIGNEE for incorporation of ASSIGNEE'S name in the records of the USPTO, as and when needed.

5. The Deed of Assignment shall be construed in accordance with the provisions of the law governed by the Patent Act (35 U.S. Code) of United States Patent and Trademark Office (the USPTO), and/or such other laws as may be prevalent for the time being.
