## ASSIGNMENT

WHEREAS, **Cornell University** desires to acquire the entire right, title and interest in and to the Patent Rights;


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

2. **Cyclofluidic Ltd** hereby authorizes and requests the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent identified in the preceding section to **Cornell University**, its successors, legal representatives, and assigns, in accordance with the terms of this instrument.


