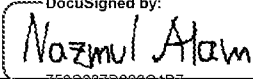

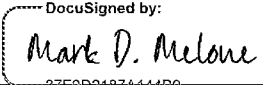

This Agreement and Assignment supersedes all other assignments, agreements and addendums related to the above identified application.

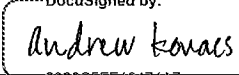

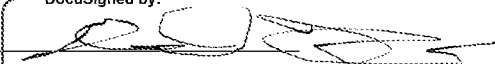
