WHEREAS, it is desired that the Assignment of the Patents be made of record in the United States Patent and Trademark Office (the "USPTO");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby conveys, delivers, assigns and transfers to Assignee its entire right, title and interest in and to the Patents, and further assigns to and authorize Assignee to file in its name applications for letters patent in all countries, the same to be held and enjoyed by Assignee, its successors, assigns, nominees or legal representatives, to the full end of the term or terms for which said letters patent respectively may be granted, reissued or extended, as fully and entirely as the same would have been held and enjoyed by the Assignor had this assignment, sale and transfer not been made.

The Assignor further covenants that it has full right to convey the entire interest herein assigned, and that it has not executed and will not execute any agreement in conflict herewith, and further covenants and agrees that it will each time request is made and without undue delay, execute and deliver all such papers as may be necessary or desirable to perfect the title to the Patents in Assignee, its successors, assigns, nominees, or legal representatives, and agrees to communicate to Assignee or to its nominee all known facts respecting the Patents, to testify in any legal proceedings, to sign all lawful papers to execute all disclaimers and divisional, continuing, reissue and foreign applications, to make all rightful oaths, and generally to do everything possible to aid Assignee, its successors, assigns, nominees and legal representatives to obtain and enforce for its or their own benefit proper patent protection for said Patents in any and all countries, all at the expense, however, of Assignee, its successors, assigns, nominees or legal representatives.

The Assignor hereby authorizes and requests the Commissioner of the USPTO and any official of any country or countries foreign to the United States whose duty it is to issue patents on applications as aforesaid, to issue to Assignee, as assignee of the entire right, title and interest, any and all Patents for said inventions or improvements, including any and all letters patent of the United States which may be issued and granted on or as a result of any application aforesaid, in accordance with the terms of this Assignment.
