2. The Certificate of Formation is hereby amended by deleting in its entirety paragraph 1 thereof and by substituting in lieu thereof the following new paragraph 1:

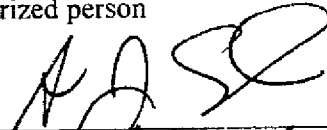
"1. The name of the limited liability company is NYSE Holdings LLC (the "LLC")."
