Kalera Medical, Inc. (the “**Corporation**”), a corporation organized and existing under the Delaware General Corporation Law (the “**DGCL**”), does hereby certify:

FIRST: The original name of the Corporation is Kalera Medical, Inc. and the date of filing the original Certificate of Incorporation of the Corporation with the Secretary of State of the State of Delaware was February 12, 2016.

SECOND: The Board of Directors of the Company (the “**Board**”), acting in accordance with the provisions of Sections 141 and 242 of the DGCL, adopted resolutions approving an amendment to the Corporation’s Second Amended and Restated Certificate of Incorporation as follows:

Article FIRST thereof shall be amended and restated to read in its entirety as follows:
