ASSIGNMENT

WHEREAS, we, **Christopher P. Hussell**, a U.S. citizen, residing at Cary, North Carolina; **Michael J. Bergmann**, a U.S. citizen, residing at Chapel Hill, North Carolina; **Brian T. Collins**, a U.S. citizen, residing at Raleigh, North Carolina; and **David T. the International Convention, the same to be held and enjoyed by the ASSIGNEE, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by us if this assignment and sale had not been made.


We hereby request that said Letters Patent be issued in accordance with this assignment.
