## PATENT ASSIGNMENT AGREEMENT

CacheIO LLC ("Assignor"), a New Hampshire Limited Liability Company, having a registered address of 330 Valley Road, Mason NH 03048,

agrees to execute this Patent Assignment Agreement ("Agreement") on this day of October 22, 2020, to assign certain US patent applications and patents owned by Assignor to

ORCA DATA TECHNOLOGY (XI'AN) CO., LTD ("Assignee"), a Chinese Limited Liability Company, having its place of business at Wenchuang Tower, 12F, Yaodian Street, Weicheng District, Xianyang, Shaanxi Province, People's Republic of China.

The terms of the Agreement are:

1. **Consideration.** The patent assignment is made in consideration of Assignee's promise to provide the second payment installment set forth in the Technology Transfer Agreement and Addendum signed between Assignor and Assignee on May 31, 2020 ("payment"). The assignment of the six patents/patent applications listed in Table A becomes effective on the date when the payment is received at Assignor's designated bank account. This Agreement shall terminate if the payment has not been received at the Assignor's designated bank account on or before November 2, 2020.
2. **Recordation.** Assignor agrees to record this Agreement at the US Patent and Trademark Office upon signing on or before October 27, 2020. In the event the payment is not received by Assignor on or before November 2, 2020, this Agreement becomes void and Assignor will record a corrective assignment to cancel the recordation of this Agreement at the USPTO.
3. **Assignment.** For the consideration set forth above, Assignor hereby agrees to assign the entire right, title, and interest in and to the applications for Letters Patent and Utility Model as listed in Table A,



- 4.3 Governing Law. This agreement shall be deemed to have been made in and shall be construed pursuant to the laws of the State of New Hampshire and the United States, without regard to conflicts of laws provisions thereof.
- 4.4 Amendments. Any amendments shall be effective only if made in writing and signed by an authorized representative of Assignor.
