ASSIGNMENT

 - iii) any and all patent applications claiming priority from the Applications, and patent applications referred to in this paragraph (b) including without limitation all foreign, national and regional phase entry patent applications, and
 - iv) any and all continuations, continuations-in-part, divisions, renewals of, substitutes or the like for the Applications and patent applications referred to in this paragraph (b), and
 - v) all Letters Patent that may be granted on or as a result of any of the Applications and Related Applications, and
 - vi) all reissues, reexaminations and extensions of said Letters Patent;

- c) the right to be granted a patent on, or as a result of, the Applications and Related Applications including without limitation the right to be granted a patent in Patent Cooperation Treaty contracting states; and
- d) any and all causes of action which may exist by reason of infringement of any of the foregoing, and any and all damages arising from past, present and future violations thereof.

AND we do hereby assign to and authorize the Assignee to, file and prosecute in our names applications for Letters Patent for said inventions or improvements in Canada, the United States of America, and all other countries, or Patent Cooperation Treaty applications or other regional or national applications, the same to be granted to, and held and enjoyed by, the Assignee, its successors, assigns, nominees or legal representatives, to the full end of the term or terms for which said Letters Patent respectively may be granted, reissued or extended, as fully and entirely as the same would have been held and enjoyed by the Assignors, had this assignment, sale and transfer not been made.

AND we hereby covenant that we have full right to convey the entire interest hereby assigned, and that we have not executed and will not execute any agreement in conflict herewith, and we further covenant and agree that we will, each time request is made by the Assignee and without undue delay or further compensation whether monetary or otherwise, execute and deliver in a timely manner all such papers as may be necessary or desirable to perfect the title to said inventions or improvements, said Application, said Related Applications and said Letters Patent, in the Assignee, its successors, assigns, nominees or legal representatives, and we agree to communicate to the Assignee, or its nominees, all known facts respecting said inventions or improvements, said Application, said Related Applications and said Letters Patent, and without further compensation whether monetary or otherwise, and in a timely fashion, to testify in any legal proceedings, to sign all lawful papers, to execute all disclaimers and divisional, continuing, reissue and foreign applications, to make all rightful oaths, and generally to do everything possible to aid the Assignee, its successors, assigns, nominees and legal representatives to obtain and enforce for its or their own benefit, proper patent protection for said inventions or improvements in any and all countries, all at the expense, however, of the Assignee or its successors, assigns, nominees or legal representatives.

AND we hereby authorize and request the Commissioner of Patents of Canada and the United States, and any official of any country or countries foreign to Canada or the United States whose duty it is to issue patents on applications as aforesaid, to issue to the Assignee, as assignee of the entire right, title and interest, any and all Letters Patent for said inventions or improvements, which may be issued and granted on or as a result of the applications aforesaid, in accordance with the terms of this Assignment.




