This assignment is dated as of December 1, 2018 (the "Effective Date"), even though the parties may have executed it after said Effective Date.

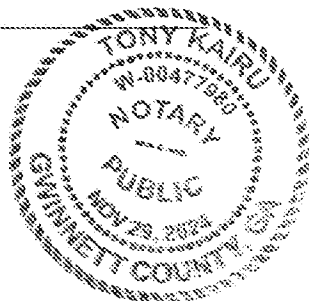
