(2) Assignor authorizes Assignee to apply in all countries in Assignor's name or in its own name for patents, utility models, design registrations, inventor's certificates and like rights of exclusion for any inventions or improvements which are disclosed in, derived from, or the subject of the Application. Assignor agrees for itself, its heirs, and its legal

representatives and assigns, without further compensation or consideration, to perform such lawful acts and to sign such further applications, assignments, preliminary statements and other lawful documents as the Assignee may reasonably request to effectuate fully this Assignment.




