
- 2.1. Licences. Subject to the provisions of this Agreement, Ten Fold hereby grants to Konrad Prefab:
 - (a) an exclusive, non-transferrable licence under the Patents and the Know-how, with the right to sub-licence as permitted in Clause 2.2, to develop, manufacture, have manufactured, market, use, and sell Licensed Products, but in each case, only in the Territory;
 - (b) an exclusive, non-transferable licence, with the right to sub-licence as permitted in Clause 2.2, to use the Trade Marks on or in connection with the promotion, advertising, distribution and sale of Licensed Products including, for the avoidance of doubt, for the creation and distribution of marketing collateral in respect of the Licensed Products and as part of any trading or company name of Konrad Prefab or of any Affiliate.

2.2 Sub-licensing.

Konrad Prefab shall be entitled to grant sub-licences of its rights under this Agreement, provided that:

- (a) any sub-licence is in accordance with the provisions of this Agreement and shall include obligations on the sub-licensee which are equivalent to the obligations on Konrad Prefab under Clauses 8 and 9 of this Agreement.
- any sub-licence shall terminate automatically on the termination of this Agreement for any reason; and
- (c) Konrad Prefab shall be responsible for any breach of the sub-licence by the sub-licensee, as if the breach had been that of Konrad Prefab under this Agreement.

This Agreement dated 10-10-2020 is between:

- (1) Ten Fold Engineering Ltd, a company incorporated in England and Wales with company number 07341960 and whose registered office is at Saxon Barn, Shillingford Road, Shillingford Hill, Wallingford, England, OX10 8LH ("Ten Fold"); and
- (2) Konrad Prefab LLC a company incorporated in Vermont with company number 0317470 and whose registered address is at 260 Clinton St, Springfield, VT, 05156, USA (the "Konrad Prefab").

Background:

A. Ten Fold has developed certain technology, including the Prototype, and owns certain intellectual property rights relating to lever-based systems, including the Patents, the Know-how and the Trade Marks.



The Parties agree as follows:

1 Definitions

In this Agreement, the following words shall have the following meanings:

Affiliate

In relation to a Party, means any person that Controls, is Controlled by, or

is under common Control with that Party.

Calendar Quarter

Means a 3 month period ending on 31 March, 30 June, 30 September or

31 December.

Claims

All demands, claims, and liability (whether criminal or civil, in contract, tort, or otherwise) for losses, damages, legal costs, and other expenses of any nature whatsoever and all costs and expenses (including legal costs)

incurred in connection therewith.

Commencement Date

10-20-2020.

Confidential Information

- (a) All Know-how; and
- (b) all other technical or commercial information that:
 - in respect of information provided in documentary or by way of a model, demonstration or in other tangible form, at the time of provision is marked or otherwise designated to show expressly or by necessary implication that it is imparted in confidence; and

- (ii) in respect of information that is imparted orally, any information that the Disclosing Party or its representatives informed the Receiving Party at the time of disclosure was imparted in confidence; and
- (iii) any copy of any of the foregoing.

Control

Direct or indirect beneficial ownership of SO% (or, outside a Party's home territory, such lesser percentage as is the maximum permitted level of foreign investment) or more of the share capital, stock, or other participating interest carrying the right to vote or to distribution of profits of that Party, as the case may be.

Diligent and Reasonable Efforts

Exerting such efforts and employing such resources as would normally be exerted or employed by a reasonable Third-Party company for a product of similar market potential at a similar stage of its product life, when utilising sound and reasonable engineering and business practice and judgment in order to develop the product in a timely manner and maximise the economic return to the Parties from its commercialisation.

Disclosing Party

Has the meaning given in Clause 8.2.

Existing Licensees



Indemnitees

Has the meaning given in Clause 10.6.

Intellectual Property

Any and all patents, utility models, registered designs, unregistered design rights, copyright, trademarks, trade names, database rights, rights in respect of confidential information, trade secrets rights under unfair competition laws, extension of the terms of any such rights, and applications for and the right to apply any of the foregoing registered property and rights, and similar or analogous rights in any part of the Territory.

Know-how

The information and copyright materials described in the attached Schedule 1 Part 8.

Licensed Products

Any and all products or services that are manufactured, sold, or otherwise supplied by Konrad Prefab or its sub-licensee (including any Affiliate of Konrad Prefab) and which:

- (a) are within any Valid Claim of the Patents;
- (b) incorporate, or their development or provision makes use of, any of the Know-how; and/or
- (c) to which the Trade Marks are to be applied or in respect of which the Trade Marks are to be used under this Agreement.

Net Sales	The invoiced price of Licensed Products sold or otherwise supplied by Konrad Prefab, its Affiliates or sub-licensees to Third Parties (other than for demonstration purposes) in arm's length transactions exclusively for money or, where the sale or supply is not at arm's length, the price that would have been so invoiced if it had been at arm's length, after deduction of all documented: (a) normal trade discounts actually granted and any credits actually given for rejected or returned Licensed Products; (b) costs of packaging, insurance, carriage, and freight, provided in each case that the amounts are separately charged on the relevant invoice; (c) Value Added Tax or other sales tax; and (d) import duties or similar applicable government levies; provided that such deductions do not exceed reasonable and customary amounts in the markets in which such sales or supply occurred. Sales or supplies between any of Konrad Prefab and its Affiliates shall not be considered for the purposes of this definition unless there is no subsequent sale to a person who is not Konrad Prefab or its Affiliate in an arm's length transaction exclusively for money.


