

Further, I agree that, upon request and without further compensation, I will communicate to said Assignee or its representatives any facts known to me respecting said inventions, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said Assignee, make all rightful oaths, and, generally do everything possible to aid said Assignee, its successors and assigns, to obtain and enforce proper protection for said inventions in the United States and its territorial possessions and in any and all foreign countries. Toward this end, Assignor agrees to cooperate with Assignee in the prosecution of the Applications and foreign counterparts; execute, verify, acknowledge, and deliver all such further papers, including patent applications and instruments of transfer; and perform such other acts as Assignee lawfully may request to obtain or maintain the Patents for the inventions in any and all countries.
