This assignment is dated as of September 10, 2019 (the "Effective Date"), even though the parties may have executed it after said Effective Date.

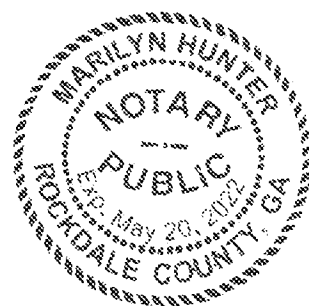
