ASSIGNOR authorizes and requests that any Official of Office of any country or countries, whose duty is to issue designs or other evidence or forms of industrial property protection on

applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument; and


ASSIGNOR covenants and agrees that he has full right to convey the entire interest herein assigned, and has not executed, and will not execute, any agreement in conflict herewith; and


