PATENT ASSIGNMENT

This PATENT ASSIGNMENT AGREEMENT ("Assignment"), effective as of ____ April , 14th _____ 2021, is made by and between:

Oneida Consumer, LLC, a Delaware limited liability company, successor by conversion of Oneida Ltd., a Delaware corporation, having a place of business at 1600 Dublin Road, East Building, Suite 200, Columbus, Ohio 43215 ("Assignor"), and

Anchor Hocking, LLC, a Delaware limited liability company, having a place of business at 1600 Dublin Road, East Building, Suite 200, Columbus, Ohio 43215 ("Assignee").

WHEREAS, Assignor owns the entire right, title and interest in and to certain inventions and patents and applications therefor;

WHEREAS, Assignor desires to assign and transfer to Assignee its entire right, title and interest in and to such inventions and patents and applications therefor; and

WHEREAS, Assignee desires to acquire the entire right, title and interest in and to such inventions and patents and applications therefor.

NOW THEREFORE, Assignor and Assignee hereby agree as follows:

1. Assignment. In consideration of the sum of U.S. One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, conveys, transfers, and assigns and transfer to Assignee, and Assignee hereby accepts, all of Assignor's right, title and interest in and to the following:

(a) the patents and patent applications listed in Exhibit A hereto, and any application(s) claiming priority therefrom, and any application(s) to which such patents and patent applications claim priority, and any non-provisionals, divisionals or continuations and continuations-in-part thereof, and the inventions therein disclosed, and any improvements thereon, and any and all Letters Patent of the United States and of countries foreign thereto that may be issued thereon or therefor including any continuation, divisional, renewal, substitute, reissue or extension therefor or legal equivalent thereof, and all associated inventions (collectively, the "Patents");

(b) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(c) any and all royalties, fees, income, payment, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future

infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. Assignor hereby authorizes the Commissioner for Patents in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by Assignee. Following the date hereof, and for the above consideration, Assignor agrees promptly upon request of Assignee, or its successors or assigns, to take such steps and actions, and provide cooperation and assistance to Assignee or its successors or assigns, including the execution and delivery without further compensation of any additional papers as may be reasonably necessary to record and fully effect, or perfect the assignment and transfer of the Patents to Assignee or its successors or assigns, in the United States or any foreign country.

3. Counterparts. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

4. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

5. Governing Law. This Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Delaware, without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction).
