KEVIN J. GUTHRIE and MICHAEL A. DEAN further grant to the Company, its successors and assigns, the right to claim for any of said applications the full benefits and priority rights of any international agreement between the United States and any foreign country or countries.

KEVIN J. GUTHRIE and MICHAEL A. DEAN hereby warrant that they have the full right to make the conveyance herein, and hereby covenant that they, their heirs, legal representatives and assigns, will, when requested, communicate to the Company, its representatives, successors and assigns, all facts known respecting said invention, execute all divisional, continuing, reissue, reexamination and foreign applications together with individual assignments therefore, make all rightful oaths, sign all lawful papers, testify in any legal proceeding and generally do everything possible to aid the Company, its successors and assigns, in the obtaining of Letters Patent.
