## DECLARATION CONFIRMING ASSIGNMENT

I, Stephen Scott, declare:

1. I am currently the United States Patent Officer at Power Systems Mfg., LLC, a Delaware limited liability company having a place of business at 1440 West Indiantown Rd., Suite 200, Jupiter, Florida 33458. I make this declaration upon personal knowledge and would testify to the facts herein.

2. On July 31, 2002, U.S. Patent Application No. 10/209,392, entitled "INSULATED COOLING PASSAGEWAY FOR COOLING A SHROUD OF A TURBINE BLADE," (the "'392 application") was filed in the U.S. Patent and Trademark Office ("USPTO"). In the various filing papers filed with the USPTO, the '392 application was assigned Attorney Docket No. PSM-062 by the legal representative who filed the application.

3. The inventor of the '392 application—Robert J. Kraft—assigned all his rights to the invention disclosed in the '392 application and to the '392 application itself to Power Systems Mfg., LLC, as evidenced by the assignment document recorded with the USPTO at reel frame no. 013162/0407 (the "Assignment Document").

4. Because the Assignment Document was executed by Mr. Kraft prior to the filing of the '392 application, the Assignment Document does not bear the '392 application's serial number. Instead, the Assignment Document includes other application identifying information including (1) the Attorney Docket No. PSM-062, (2) the inventor's name, and (3) the title of the invention.


5. After a recent inspection of the Assignment Document, it was discovered that the Assignment Document contains a typographical error in that, in the title of the invention, the word "a" was omitted following the word "of" and preceding the word "Turbine." Namely, the

title of the invention, as included in the Assignment Document, was inadvertently listed as "Insulated Cooling Passageway for Cooling a Shroud of Turbine Blade" rather than the correct title of "Insulated Cooling Passageway for Cooling a Shroud of a Turbine Blade" (emphasis added for clarity). Other identifying information, including the inventor name ("Robert J. Kraft") and the Attorney Docket No. ("PSM-062") appear correctly on the Assignment Document.

6. For the avoidance of doubt, I have reviewed the '392 application, the '392 application's file, and the Assignment Document, and hereby confirm that the Assignment Document was intended to transfer all rights to the invention disclosed in the '392 application and to the '392 application itself to Power Systems Mfg., LLC, notwithstanding the inadvertent omission of the word "a" in the title listed on the Assignment Document.

7. I declare under penalty of perjury that the foregoing is true and correct.
