PATENT ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, inventors Ronald G. Presswood Jr. and Ian C. (c) all reissues, reexaminations, extensions, continuations, continuations in part claiming priority to the Patents filed after April 6, 2019, continuing prosecution applications, requests for continuing examinations, divisions, registrations of any item in any of the foregoing categories (a) and (b);

(d) all foreign patents, patent applications, and counterparts relating to any item in any of the foregoing categories (a) through (c), including, without limitation, certificates of invention, utility models, industrial design protection, design patent protection;

(e) all causes of action (whether known or unknown or whether currently pending, filed, or otherwise) and other enforcement rights under, or on account of, any of the Patents and/or any item in any of the foregoing categories (a) through (d), including, without limitation, all causes of action and other enforcement rights for:

(i) damages, past, present, or future;

(ii) injunctive relief;

(iii) any other remedies of any kind for past, current, and future infringement; and

(f) all rights to collect royalties and other payments under or on account of any of the Patents and/or any item in any of the foregoing categories (a) through (e).

AND for the same consideration, Assignors hereby represent and warrant to Assignee, its successors, legal representatives, and assigns, that, at the time of execution and delivery of these presents, except for any rights, titles, and/or interests that have arisen to Assignee under law or that have already been transferred to Assignee, Assignors are the sole and lawful owners of the entire right, title, and interest in and to the said inventions, patents and applications for the above-mentioned Patents, and that the same are unencumbered, except as expressly set forth in

the Shareholder Agreement dated April 6, 2019 (the "Agreement") and that Assignors have good and full right and lawful authority to sell and convey the same in the manner according to the terms of this Patent Assignment and the Agreement.

AND for the same consideration, set forth herein and in the Agreement, Assignors hereby covenant and agree to and with Assignee, its successors, legal representatives, and assigns, that Assignors will sign all papers and documents, take all lawful oaths and do all acts necessary or required to be done for the procurement, maintenance, enforcement, and defense of any Patents and Patent applications for said inventions, whenever counsel of Assignee, or counsel of its successors, legal representatives and assigns, shall advise: that any proceeding in connection with said inventions, or said Patent application, or any proceeding in connection with any Patents or Patent applications for said inventions in any country, including but not limited to post issuance proceedings, is lawful and desirable; or, that any division, continuation, or continuation-in-part filed after April 6, 2019 of any Patent application, or any reissue, reexamination, or extension of any Patent, to be obtained thereon, is lawful and desirable.

AND Assignors hereby authorize the respective patent office or governmental agency in each jurisdiction to issue any and all patents, certificates of invention, utility models, or other governmental grants or issuances that may be granted upon any of the Patent Rights in the name of Assignee, as the assignee to the entire interest therein.

AND the terms and conditions of this Patent Assignment will inure to the benefit of Assignee, its successors, assigns, and other legal representatives and will be binding upon Assignors, their successors, assigns, and other legal representatives.

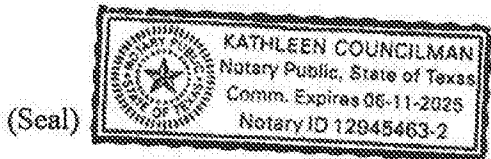

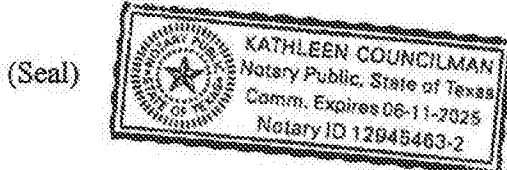
