AND Assignor hereby authorizes and empowers Assignee or nominees to invoke and claim for any application for such Letters Patent or other grants of protection for said Inventions filed by it or them, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by a convention which may henceforth be substituted for it, and to invoke and claim such right of priority without further written or oral authorization from such Assignor;

AND Assignor hereby consents that a copy of this Assignment shall be deemed a full and formal equivalent of any assignment, consent to file or like document which may be required in any country or region for any purpose and more particularly in proof of the right of Assignee or nominees to claim the aforesaid benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it;

AND Assignor hereby covenants that such Assignor has the full right to convey the right, title and interest herein assigned and that such Assignor has not executed and will not execute any agreement in conflict herewith;

AND Assignor hereby covenants and agrees that such Assignor will communicate to Assignee or nominees all facts known to such Assignor pertaining to said Inventions, and testify in all legal proceedings, sign all lawful papers, execute all non-provisionals, divisionals, continuations, continuations-in-part, refilings, renewals, substitute and reissue applications, make all rightful oaths and declarations and in general perform all lawful acts necessary or proper to aid Assignee or nominee in obtaining, maintaining and enforcing all lawful patent or other grants of

protection of said Inventions in any and all countries and regions.


