PARTIAL RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This PARTIAL RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “*Release*”) is made as of July 30, 2021 by HSBC Bank USA, National Association, as collateral agent (in such capacity and any successor in such capacity, the “*Collateral Agent*”) for the Secured Parties (as defined in the Security Agreement referred to below), in favor of Samsonite IP Holdings S.à r.l., a *société à responsabilité limitée* (private limited liability company) governed by the laws of the Grand-Duchy of Luxembourg, having its registered office at 13-15 avenue de la Liberté, L-1931 Luxembourg, registered with the Luxembourg Register of Commerce and Companies (*Registre de Commerce et des Sociétés, Luxembourg*) under number B 147.735 with a share capital of USD 114,115,900 (the “*Grantor*”).

WHEREAS, reference is made to that certain Credit and Guaranty Agreement, dated as of May 13, 2016 (as amended, amended and restated, supplemented, waived or otherwise modified from time to time, the “*Credit Agreement*”), entered into by and among PTL Acquisition Inc., a Delaware corporation, as a “Borrower”, the other Borrowers party thereto from time to time, the Guarantors party thereto from time to time, the Lenders party thereto from time to time, HSBC Bank USA, National Association, as TLA and Revolver Administrative Agent (together with its permitted successors in such capacity, “*TLA and Revolver Administrative Agent*”) and as Collateral Agent (together with its permitted successors in such capacity, “*Collateral Agent*”), and Morgan Stanley Senior Funding, Inc., as TLB Administrative Agent (together with its permitted successors in such capacity, “*TLB Administrative Agent*” and together with the TLA and Revolver Administrative Agent, the “*Administrative Agents*”);

WHEREAS, in connection with the 2011 PBGC Settlement Agreement and the making of Loans by the Lenders and the entry into Hedge Agreements and Cash Management Agreements by the Lender Counterparties from time to time, the Grantor executed and delivered that certain Intellectual Property Security Agreement, dated as of August 1, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Security Agreement*”), by and among the Grantor, the Administrative Agents and the Collateral Agent;

WHEREAS, under the terms of the Security Agreement, the Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantor, and agreed as a condition thereof to execute (a) that certain Short Form Intellectual Property Security Agreement, dated as of August 1, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*First IP Security Agreement*”), (b) that certain Supplemental Intellectual Property Security Agreement, dated as of April 25, 2018 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Second IP Security Agreement*”), (c) that certain Supplemental Intellectual Property Security Agreement, dated as of March 16, 2020 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Third IP Security Agreement*”), (d) that certain Supplemental Intellectual Property Security Agreement, dated as of April 29, 2020 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Fourth IP Security Agreement*”), (e) that certain Supplemental Intellectual Property Security Agreement, dated as of May 7, 2020, 2020 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Fifth IP Security Agreement*”), (f) that certain Supplemental Intellectual Property Security Agreement, dated as of June 7, 2021 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Sixth IP Security Agreement*”), (g) that certain Supplemental Intellectual Property Security Agreement, dated as of June 21, 2021 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Seventh IP Security Agreement*” and, together with the First IP Security Agreement, the Second IP Security Agreement, the Third IP Security Agreement, the Fourth IP Security Agreement, the Fifth IP Security Agreement, Sixth IP Security Agreement and the Seventh IP Security Agreement, the

“IP Security Agreements”), for recording with the United States Patent and Trademark Office, the United States Copyright Office, the CIPO and the EUIPO;

WHEREAS, (a) the First IP Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on August 2, 2016 at Reel 039548, Frame 0001, with the Trademark Division of the United States Patent and Trademark Office on August 2, 2016 at Reel 5845, Frame 0594, and with the United States Copyright Office on August 10, 2016 at Volume 9940, Document 480, (b) the Second IP Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on April 27, 2018 at Reel 045651, Frame 0333, and with the Trademark Division of the United States Patent and Trademark Office on April 27, 2018 at Reel 6321, Frame 0366, (c) the Third IP Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on May 17, 2018 at Reel 046177, Frame 0202, and with the Trademark Division of the United States Patent and Trademark Office on May 17, 2018 at Reel 6386, Frame 0903, (d) the Fourth IP Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on August 14, 2019 at Reel 050056, Frame 0649, and with the Trademark Division of the United States Patent and Trademark Office on August 14, 2019 at Reel 6720, Frame 0368, (e) the Fifth IP Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on March 27, 2020 at Reel 052242, Frame 0092, and with the Trademark Division of the United States Patent and Trademark Office on March 27, 2020 at Reel 6901, Frame 0437, (f) the Sixth IP Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on May 11, 2020 at Reel 052628, Frame 0221, and with the Trademark Division of the United States Patent and Trademark Office on May 29, 2020 at Reel 6948, Frame 0931, and (g) the Sixth IP Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on July 1, 2021 at Reel 056732, Frame 0218, and with the Trademark Division of the United States Patent and Trademark Office on July 1, 2021 at Reel 7342, Frame 0899; and

WHEREAS, in accordance with the provisions of the Credit Agreement, the TLA and Revolver Administrative Agent, the Security Agreement and the IP Security Agreements, the Collateral Agent, on behalf of itself and the Secured Parties, now desires to terminate and release its security interest in and to certain of the IP Collateral (as defined in the IP Security Agreements) with respect to the Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Defined Terms. Unless otherwise specified herein, all capitalized terms used but not defined herein have the meanings given to them in the Credit Agreement or the IP Security Agreements.

SECTION 2. Release of Grant of Security in the Released Collateral. The Collateral Agent, on behalf of itself and the Secured Parties, hereby terminates, releases and discharges to the Grantor (as defined herein) all of the Collateral Agent’s and the Secured Parties’ security interest in all of the Grantor’s right, title and interest in and to, and reassigns to the Grantor (as defined herein) any right, title and interest the Collateral Agent or any Secured Party may have in or to, the following (the *“Released Collateral”*):

(i) the trademark and service mark registrations and applications set forth in Schedule A hereto (including any United States intent-to-use trademark applications or intent-to-use service mark applications filed pursuant to Section 1(b) of the Lanham Act), together, in each case, with the goodwill symbolized thereby (the *“Trademarks”*);

- (ii) the patents and patent applications set forth in Schedule B hereto (the "*Patents*");
- (iii) the copyright registrations and applications set forth in Schedule C hereto (the "*Copyrights*");
- (iv) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of the Grantor accruing thereunder or pertaining thereto;
- (v) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and
- (vi) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to or arising from any of the foregoing.

SECTION 3. Effect of Release. For the avoidance of any doubt, the release hereunder is limited only and solely to the Grantor (as defined herein) and to the Released Collateral (as defined herein), and shall not apply in any respect to any other parties to the IP Security Agreements or to any other of the IP Collateral (as defined in the IP Security Agreements). The Collateral Agent reserves and retains its security interest (and any other right, title or interest) in and to all intellectual property of such other parties and all other IP Collateral of the Grantor (other than the Released Collateral), which security interest remains uninterrupted and undisturbed. Except as expressly modified by this Release, the IP Security Agreements remains and shall remain in full force and effect.

SECTION 4. Recordation. The Collateral Agent authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks, the CIPO, the EUIPO and any other applicable government officer record this Release.

SECTION 5. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
