Tenaya Way, Suite 100, Las Vegas, Nevada 89113, **GCA MTL, LLC**, a Delaware limited liability company with an address at 7250 S. Tenaya Way, Suite 100, Las Vegas, Nevada 89113, **CENTRAL CREDIT, LLC**, a Delaware limited liability company with an address at 7250 S. Tenaya Way, Suite 100, Las Vegas, Nevada 89113, **EVERI INTERACTIVE LLC**, a Delaware limited liability company with an address at 7250 S. Tenaya Way, Suite 100, Las Vegas, Nevada 89113, and **EVERI GAMES INC.**, a Delaware corporation with an address at 7250 S. Tenaya Way, Suite 100, Las Vegas, Nevada 89113 (each, a “Grantor”, and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors entered into a certain patent security agreement dated April 21, 2020 (the “Patent Security Agreement”) with Collateral Agent, notice of which was recorded on April 24, 2020 at the United States Patent and Trademark Office at Reel 052494, Frame 0463.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Patent Security Agreement.

WHEREAS, each Grantor granted the Collateral Agent, under the terms of the Patent Security Agreement, a security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of each such Grantor’s right, title and interest in the Patent Collateral, including without limitation the patents listed in **Schedule A**.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Patent Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby releases, terminates and discharges any and all of its interest in the Patent Collateral of the Grantors, and assigns, transfers and conveys to the Grantors the Security Interest in such Patent Collateral.
