TERMINATION OF PATENT SECURITY AGREEMENT

This **TERMINATION OF PATENT SECURITY AGREEMENT** (this "Termination"), dated as of August 12, 2021, is made by **ARES CAPITAL CORPORATION**, a **Maryland corporation**, in its capacity as agent for the Lenders (in such capacity, the "Agent"), in favor of **CARDIACASSIST, INC.** ("Grantor"). Unless otherwise defined herein, capitalized terms used in this Termination shall have the meanings assigned to such terms in the Patent Security Agreement (as defined below).

WHEREAS, the Grantor and the Agent entered into that certain Patent Security Agreement, dated as of July 17, 2020 (the "Patent Security Agreement"), which was recorded with the United States Patent and Trademark Office on July 17, 2020 at Reel/Frame 052963/0372, as supplemented from time to time;

WHEREAS, pursuant to (i) that certain Guarantee and Collateral Agreement, dated as of July 17, 2020 (as amended, modified, extended, restated, renewed, replaced, or supplemented from time to time, the "Security Agreement"), by and among the Grantor party thereto from time to time and the Agent and (ii) the Patent Security Agreement, the Grantor pledged and granted to the Agent a security interest in certain Collateral, including all of the Grantor's right, title and interest in, to and under the United States patents and patent applications listed on Exhibit A attached hereto and the right to receive Proceeds of any of the foregoing, in each case, arising under the Security Agreement and the Patent Security Agreement (collectively, the "Patent Collateral"); and

WHEREAS, the Agent acknowledges complete payment and performance of all Secured Obligations (other than Unasserted Contingent Obligations), and as a result has agreed to terminate, cancel, release and discharge its security interest in the Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent hereby (i) absolutely, unconditionally and irrevocably terminates, cancels, releases and discharges the security interest in the Patent Collateral and any and all other Liens and security interests that the Agent or its predecessors, successors, assigns and transferees may have in, to or on the Patent Collateral and (ii) terminates and cancels the Patent Security Agreement.
2. The Agent represents and warrants that it has full authority to execute and deliver this Termination.
3. The Agent hereby authorizes and requests that the Commissioner for Patents record this Termination. At the request of the Grantor, at the Grantor's expense, the Agent agrees to execute and deliver such other and further documents and instruments reasonably requested by the Grantor in writing in order to effect or evidence more fully the matters covered by this Termination.

4. THIS TERMINATION SHALL BE GOVERNED BY AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.

5. This Termination shall be binding upon the Agent's representatives, successors, assigns and transferees.
