PATENT ASSIGNMENT

This Patent Assignment is by and between Platinum Plus Printing, LLC, a Minnesota limited liability company having an address at 400 Congress Street West, Maple Lake, MN 55358 ("Platinum Plus Printing") and James Whelan, a resident of Louisiana having an address at 4729 Alexander drive, Metairie, La 70003 ("Whelan").

Background. Platinum Plus Printing is the owner by assignment of U.S. Pat. No. D698,867, App. Ser. No. 29/422,491, entitled "Electric Code Display Device" (issued February 4, 2014) (the "Assigned Patent"), via that certain Assignment dated August 24, 2012, signed by Carl Hensley and recorded with the U.S. Patent and Trademark Office at Reel: 028858, Frame: 0220 (the "Hensley Assignment"). Platinum Plus Printing now desires to assign to Whelan, and Whelan desires to accept, all rights, title, and interest in the Assigned Patent in accordance with the provisions of this Patent Assignment.

Platinum Plus Printing further hereby assigns to Whelan all rights in the Hensley Assignment. Platinum Plus Printing further covenants that, upon request by Whelan and for no additional consideration, Platinum Plus Printing will provide all pertinent facts and documents relating to said Assigned Patent as may be known and accessible to Platinum Plus Printing and will testify as to the same in any interference, litigation or proceeding related thereto and will promptly execute and deliver to Whelan or his legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce the Assigned Patent which may be necessary or desirable to carry out the purposes of this Patent Assignment.

3. **Other Provisions.** Platinum Plus Printing represents and warrants that no assignment, sale, agreement, or encumbrance has been or will be made or entered into which would conflict with this Patent Assignment. This Patent Assignment shall be governed by the laws of the State of Louisiana, except its conflicts of law rules.
