AND we do hereby acknowledge and agree that Assignee, as the assignee of the entire right, title and interest thereto, shall have sole control over and sole and absolute discretion with




AND we do hereby authorize and request that any patents issuing from any of the Subject Property be issued to Assignee, as the assignee of the entire right, title and interest thereto.
