1. Assignment of Patents and/or Patent Applications. Each INVENTOR hereby irrevocably assigns, transfers, and conveys to ASSIGNEE all of his or her respective right, title, and interest in, to, and under the inventions and patent applications and patents set forth below:

European Union Community Design Application No. 007330501-0002, filed December 3, 2019, entitled "CONFECTIONERY"; and

United States Design Patent Application No. 35/509,400, filed May 4, 2020, entitled "CONFECTIONERY", which claims priority to the above-referenced EU Community Design Application,

both of which are hereby incorporated by reference herein, including, without limitation, (i) all inventions and improvements disclosed therein, (ii) all letters patent or similar legal protection granted therefor in the United States, its territorial possessions, and in all foreign countries, unions, or regions, (iii) all continuations, divisions, continuations-in-part, substitutions, reissues, renewals, substitutes, and extensions thereof and applications therefor, in the United States and its territorial possessions and in all foreign countries, unions, or regions, (iv) any and all patents and patent applications that claim priority to any of the foregoing, and (v) all rights to enforce including, but not limited to, the right to sue and collect damages for any past or future infringements throughout the world (collectively, the "Assigned Rights").

The assignments referenced herein may have multiple effective dates as this is a confirmatory assignment for any filings that predate the Effective Date. As such, this Assignment confirms the full assignment of rights in the Assigned Rights to ASSIGNEE from the INVENTORS as of at least the filing dates for all Assigned Rights, including without limitation, the patent applications (and registration) identified herein.

2. Filing and Recording Instruments of Transfer. Each INVENTOR hereby constitutes and appoints ASSIGNEE, and its successors and assigns, the true and lawful attorney or attorneys in fact of such INVENTOR, with the full power of substitution, for it and in its name and stead or otherwise, to institute and prosecute from time to time, any proceedings at law, in equity, or otherwise, that ASSIGNEE, or its successors or assigns, may reasonably deem proper in order to assert or enforce any claim, right, or title of any kind in and to the Assigned Rights, and to defend and compromise any and all actions, suits, or proceedings, in respect to any of the foregoing, and generally to do any and all such acts and things in relation thereto as ASSIGNEE, or its successors or assigns, shall reasonably deem advisable, including, but not limited to, the execution and delivery of any and all assignments and instruments in furtherance hereof. Each INVENTOR declares that the appointment hereby made and the powers hereby granted are coupled with an interest and irrevocable.




