## INVENTION ASSIGNMENT

**WHEREAS**, Assignors believe themselves to be the original, first, and/or sole inventors of the Invention disclosed and claimed in Exhibit A; and

4. Agreement to cooperate. Assignors hereby agree, without further consideration and without expense to Assignee, to sign all lawful papers and to perform all other lawful acts which the



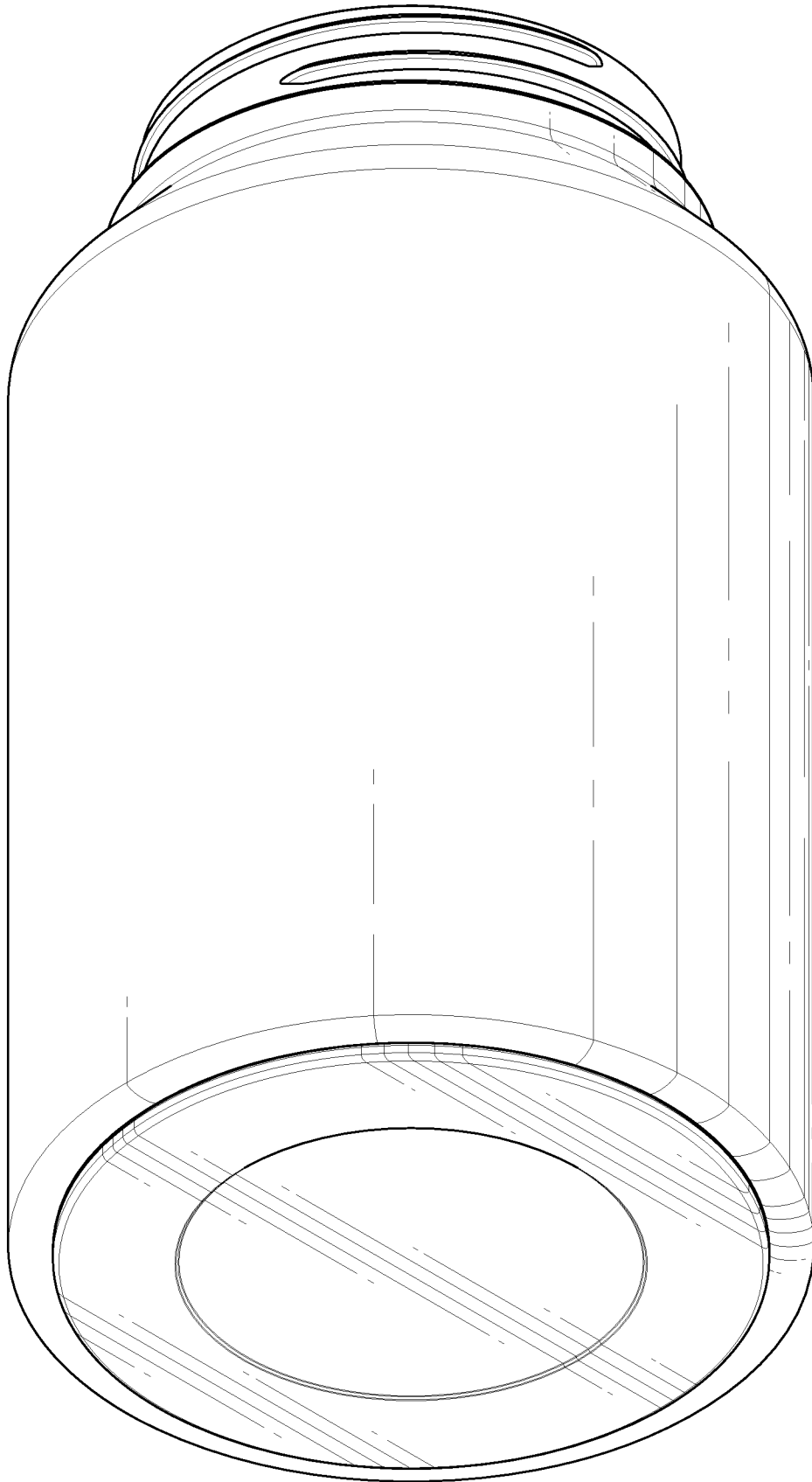

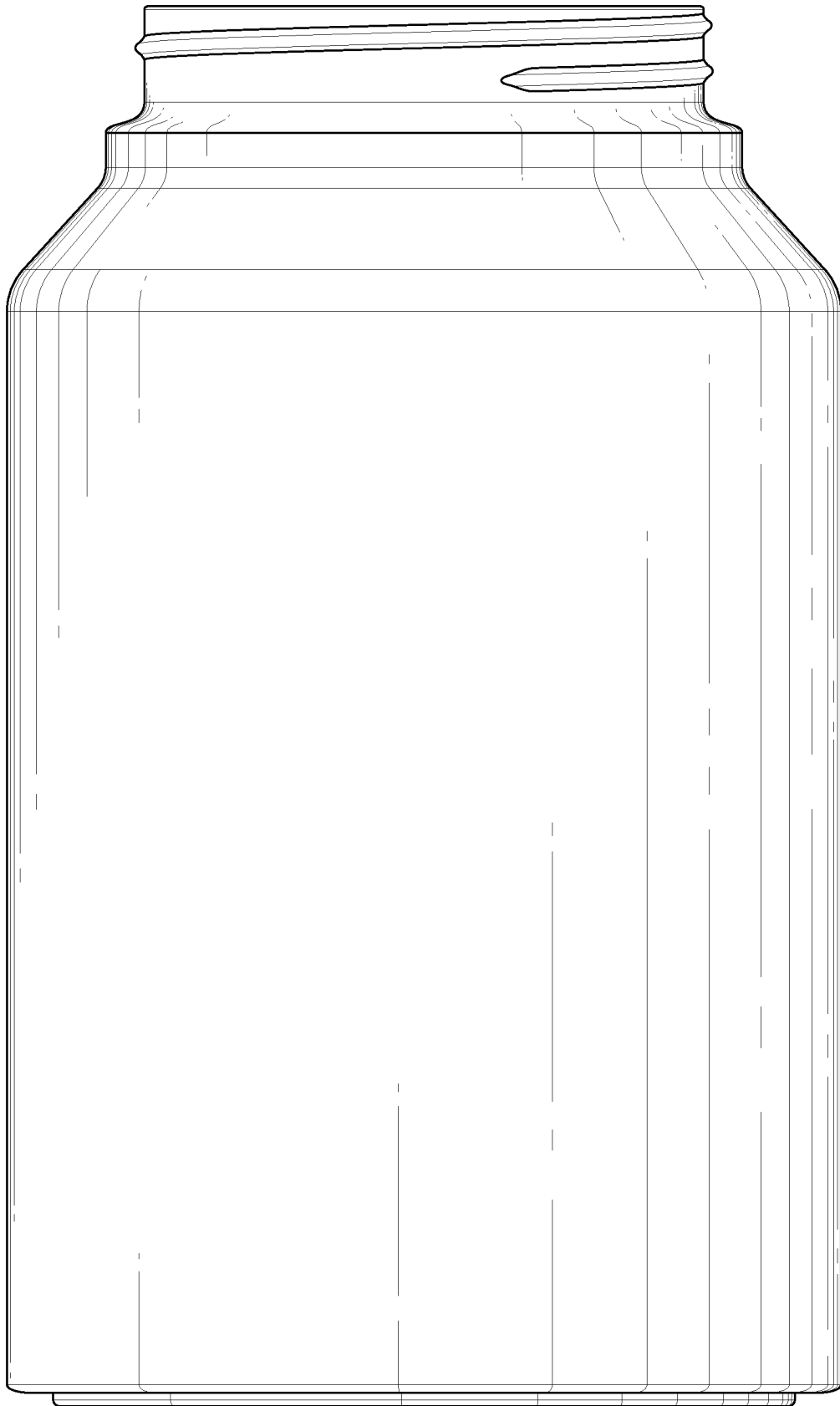

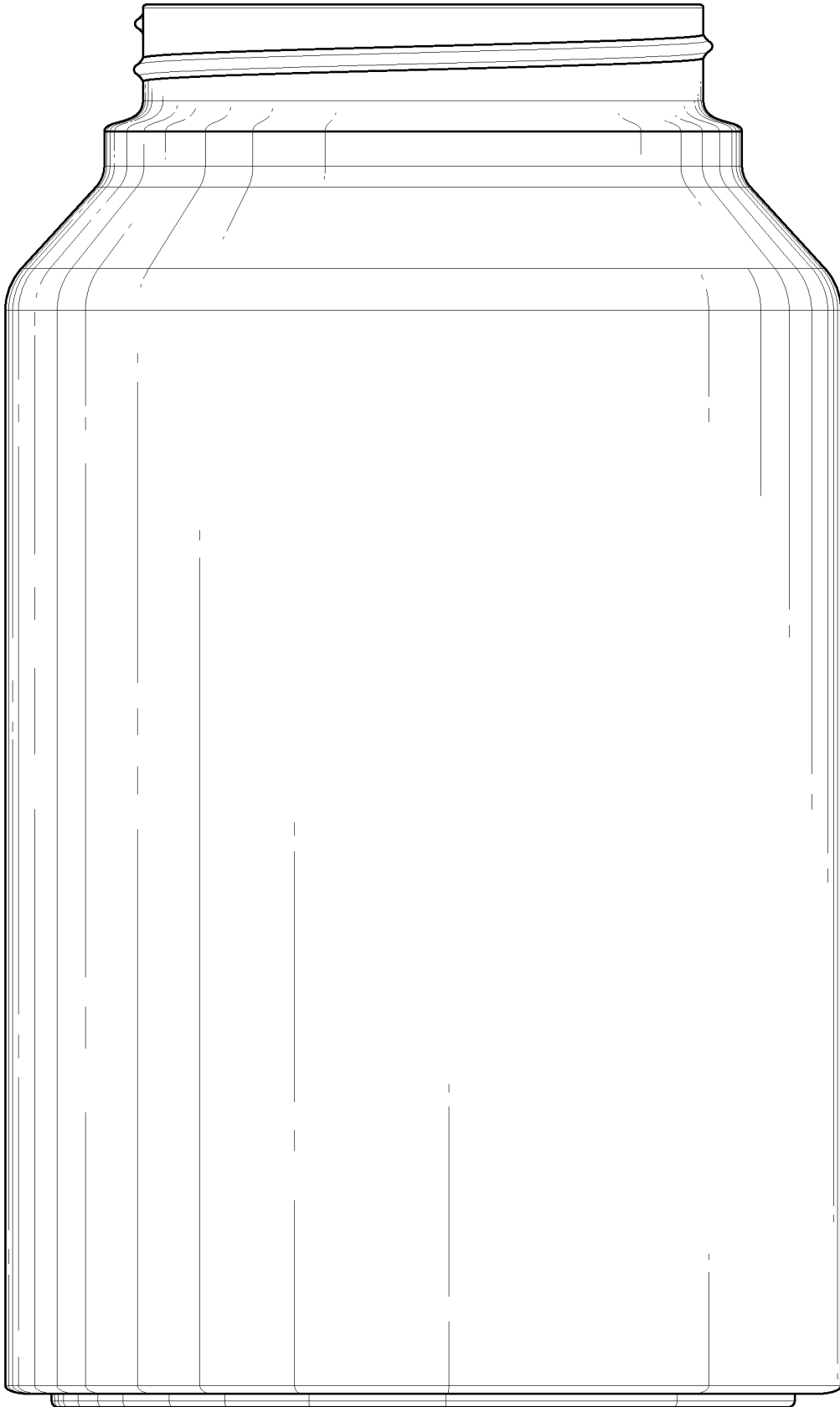

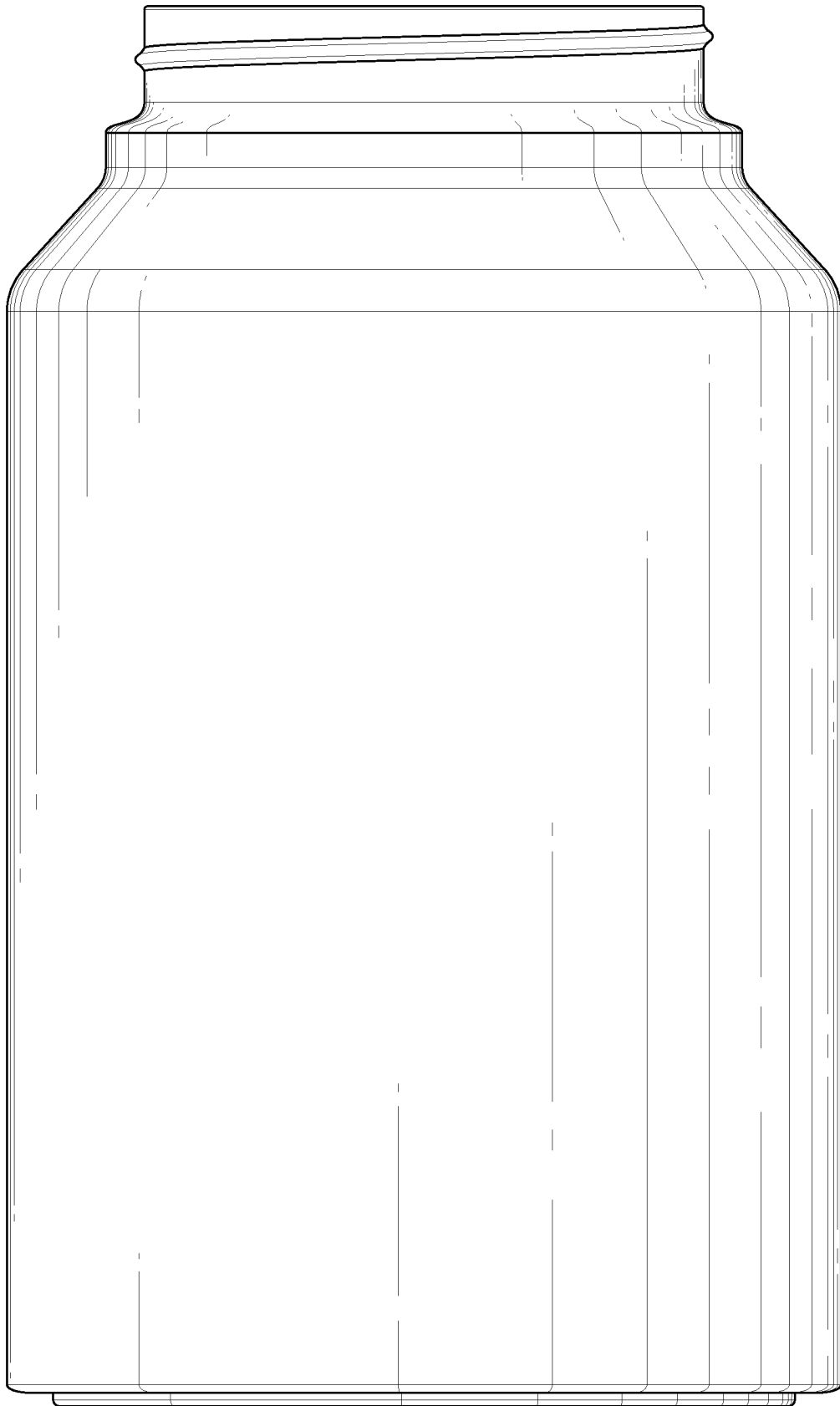

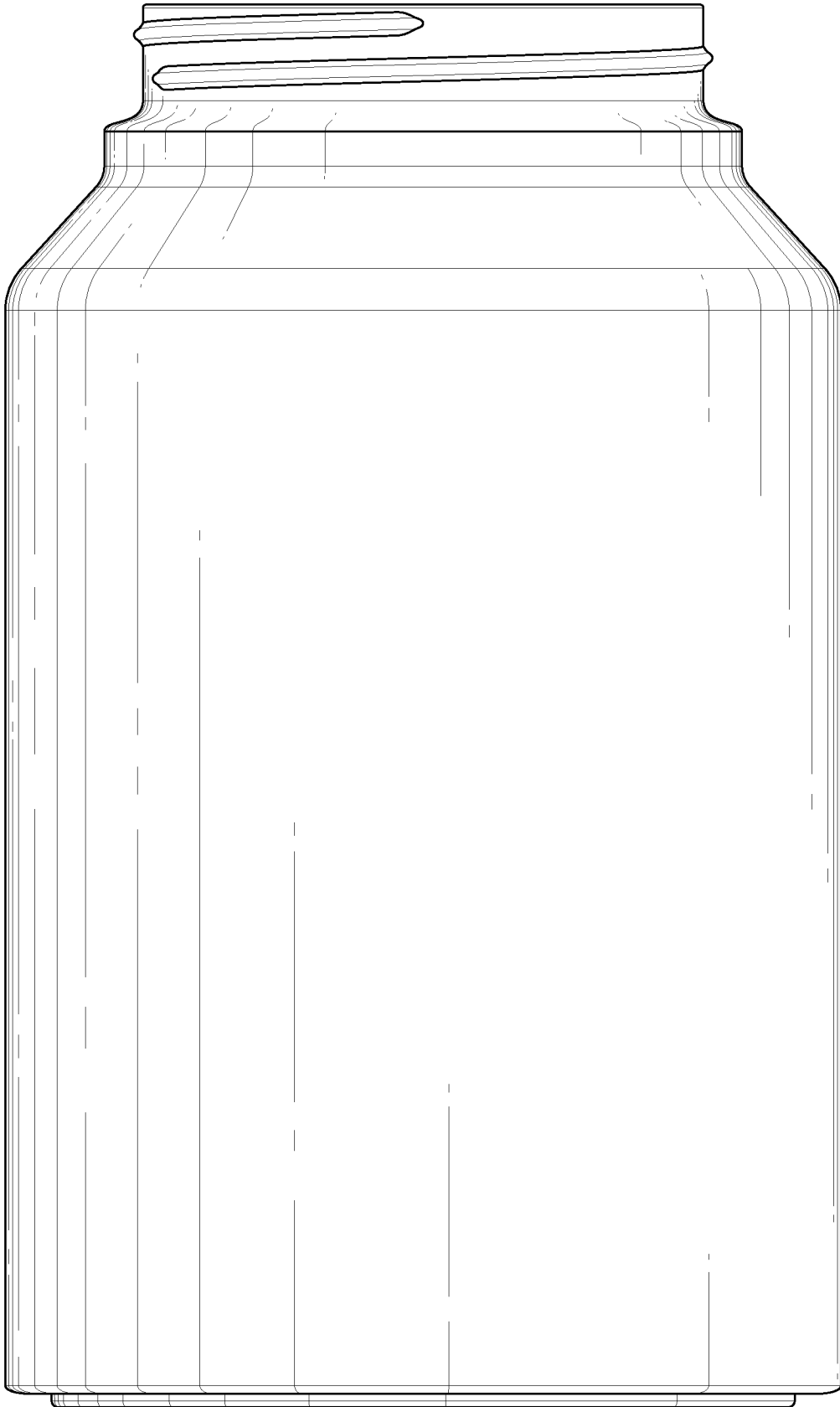

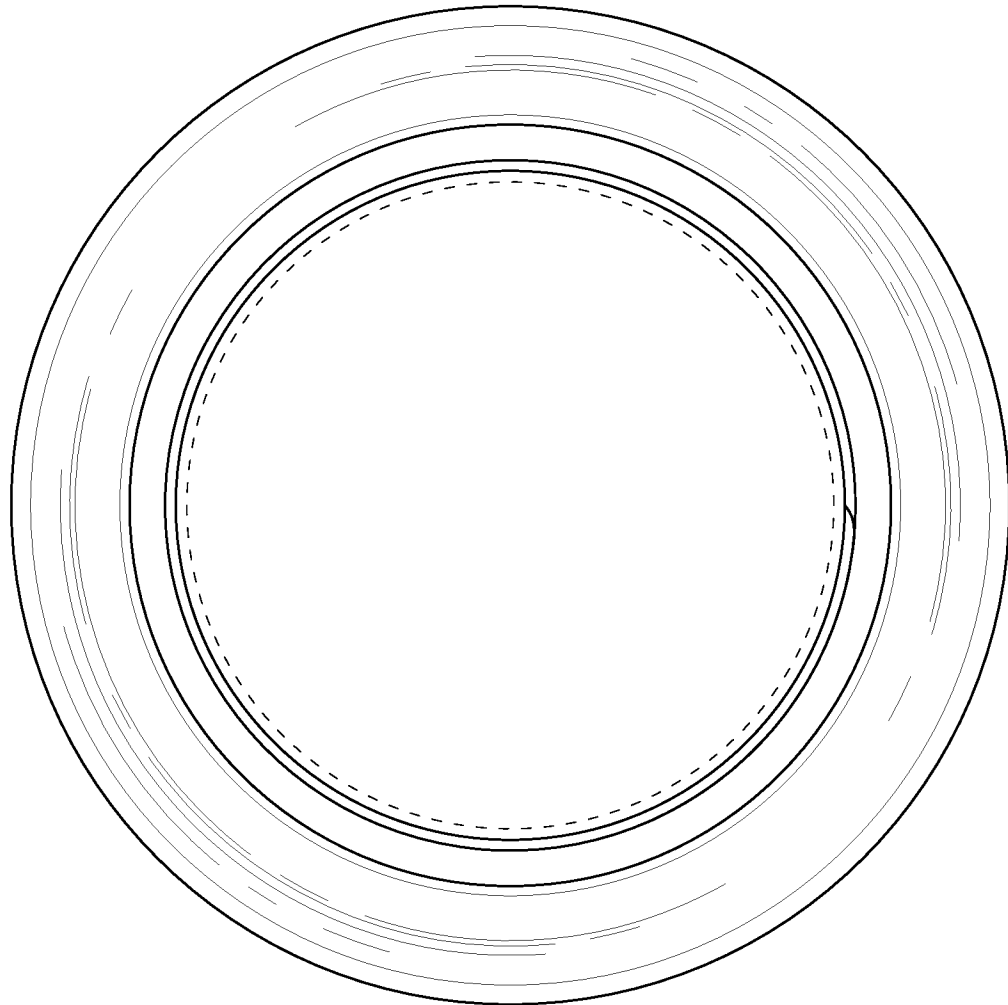

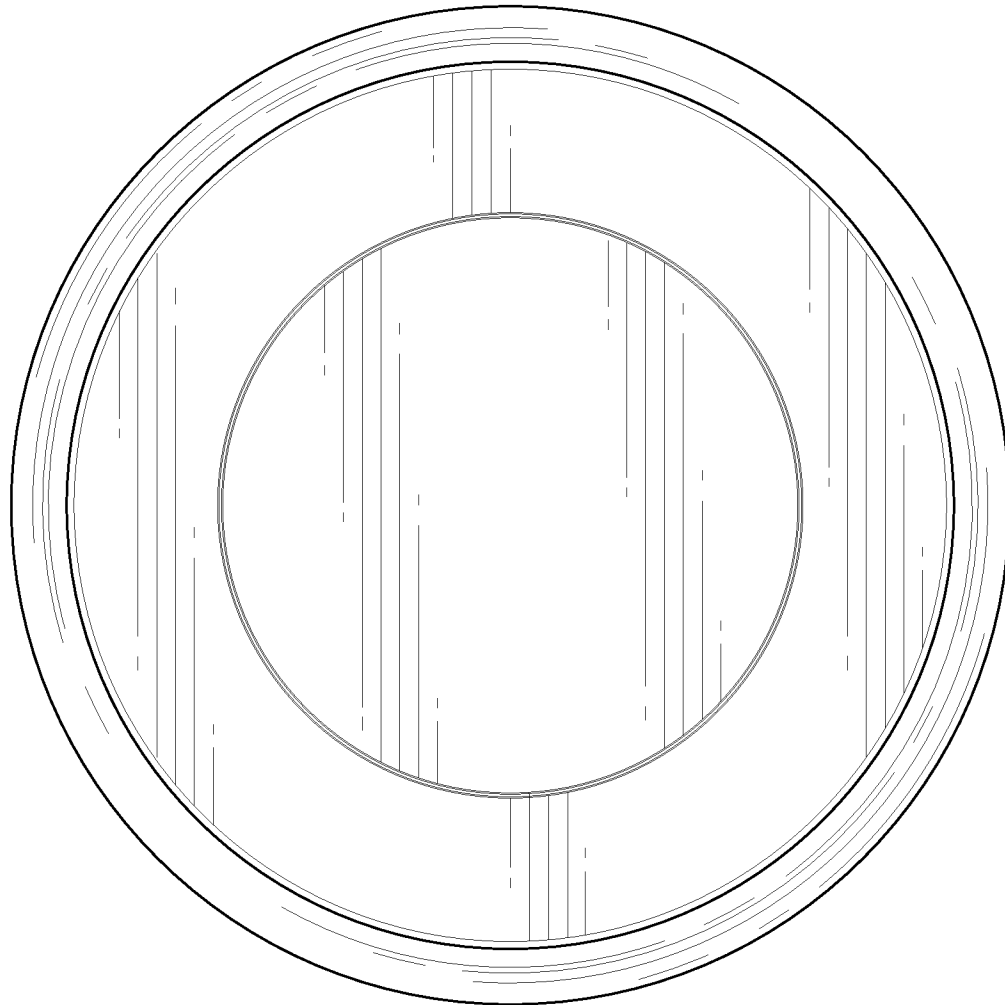
