AND I HEREBY further covenant and agree, that I will communicate to Assignee any facts known to me respecting said invention and Patents, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuations-in-part, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid Assignee to obtain and enforce proper patent protection for said invention and Patents in all countries.
