## ASSIGNMENT AND ASSUMPTION AGREEMENT

This Assignment and Assumption Agreement (this “Agreement”), dated June 1, 2021, is made by and among Flint Hills Resources, LP, a Delaware limited partnership, Flint Hills Resources, LC, a Kansas limited company, Flint Hills Resources, LLC, a Delaware limited liability company, Koch Industries, Inc., a Kansas corporation, KBX Rail, LLC, a Delaware limited liability company, and KLRX, LLC, a Delaware limited liability company (collectively, the “Assigning Affiliates”), Flint Hills Resources Grain, LLC, a Delaware limited liability company (“FHR Grain”) and Flint Hills Resources Railroad, LLC, a Delaware limited liability company (“FHR Railroad”, and together with FHR Grain, the “Specified Purchased Companies”). The Assigning Affiliates and Specified Purchased Companies are referred to herein individually as a “Party” and collectively as the “Parties”. Capitalized terms used but not defined in this Agreement will have the meanings ascribed to such terms in the Purchase Agreement (as defined below).

### RECITALS

A. Immediately following the execution and delivery of this Agreement, FHR B&I Holdings, LLC, a Delaware limited liability company (“Seller”), POET Biorefining (Octane) Holdings, LLC, a Delaware limited liability company (“Purchaser”) and POET Investments, LLC, a Delaware limited liability company, will enter into that certain Equity Purchase Agreement (the “Purchase Agreement”), pursuant to which, among other terms, Seller will sell to Purchaser, and Purchaser will purchase from Seller, the Company Equity for the Purchase Price, upon the terms set forth therein.

B. Section 2.2(a)(i) of the Purchase Agreement contemplates that Seller will provide (or cause to be provided) to Purchaser an executed copy of this Agreement at the Closing, which is taking place immediately following the execution and delivery of this Agreement.

C. The Assigning Affiliates desire to execute and deliver to the Specified Purchased Companies this Agreement as contemplated by Section 2.2(a)(i) of the Purchase Agreement.

In consideration of the promises and the mutual covenants and agreements set forth herein (including the recitals hereof), the Parties hereby agree as follows:

1. Specified Affiliate Assets.

(a) FHR Grain.

i. Assigned Contracts. Subject to the terms, conditions and limitations set forth in the Purchase Agreement, each of the Assigning Affiliates hereby (i) assigns, conveys and transfers to FHR Grain all of such Assigning Affiliate’s right, title and interest in, to and under the Contracts set forth in Section I on Exhibit A (the “FHR Grain Assigned Contracts”) and (ii) transfers, assigns and delegates to FHR Grain all Liabilities arising from such Assigning Affiliates’ right, title and interest in, to and under the FHR Grain Assigned Contracts prior to the Closing.

ii. Other Specified Affiliate Assets. Subject to the terms, conditions and limitations set forth in the Purchase Agreement, each of the Assigning Affiliates hereby (i) assigns, conveys and transfers to FHR Grain all of such Assigning Affiliate's right, title and interest in, to and under the Specified Affiliate Assets (other than the FHR Grain Assigned Contracts) set forth on Exhibit A and (ii) transfers, assigns and delegates to FHR Grain all Liabilities arising from such Assigning Affiliates' right, title and interest in, to and under the Specified Affiliate Assets (other than the FHR Grain Assigned Contracts) set forth on Exhibit A prior to the Closing.

iii. Acceptance. Subject to the terms, conditions and limitations set forth in the Purchase Agreement, FHR Grain hereby (i) accepts and assumes the transfer, assignment and delegation contemplated by Sections 1(a)(i) and 1(a)(ii), and (ii) agrees to timely pay, perform and discharge all Liabilities of the Assigning Affiliates arising from the Assigning Affiliates' right, title and interest in, to and under the Specified Affiliate Assets set forth on Exhibit A.


