

Diepenbrock to litigate and enforce any property rights in the category of patents, copyrights, trade secrets, and related technology, against any others who may have previously infringed upon the same, are currently infringing, or may infringe in the future, including the right to obtain any judgment for damages, injunctive relief, or other awards to be made by any court, for violation of the property rights as assigned herein; and Jeffrey D. Sheets herein agrees to execute any legal documentation required by William R. Diepenbrock to enforce said rights, and litigate the same in the courts, without any cost to Jeff Sheets.
