# CONFIRMATORY ASSIGNMENT OF INVENTION

And ASSIGNOR hereby authorizes and requests the Commissioner of Patents and Trademarks to issue said United States Letters Patent to said ASSIGNEE as the assignee of its whole right, title, and interest thereto.

And ASSIGNOR further agrees to sign and properly execute such necessary and lawful papers for application for patents, for filing subdivisions of said applications for patents, and for obtaining any reissue or reissues of any Letters Patent which may be granted for its aforesaid improvements, as the assignee thereof shall hereafter require and prepare at its own expense.
