CONFIRMATORY ASSIGNMENT OF PATENT RIGHTS



Assignor further memorializes hereby that the Assignee has the right to claim priority to U.S. Appl. No. 62/349,639 filed June 13, 2016.

Nothing in this Agreement shall amend, modify or otherwise affect the terms or conditions of the MPCA and PS, which remain in full force and effect on the terms and conditions stated therein. The parties execute this valid, binding, and enforceable agreement by their authorized signatures below.


