RESOLVED, that Article I of the Certificate of Incorporation of the Corporation be amended by deleting Article I in its entirety and replacing it with the following:

ARTICLE I

Name

The name of the Corporation is OQ Chemicals Corporation (the "*Corporation*").

SECOND: The Certificate of Amendment to the Certificate of Incorporation has been duly adopted in accordance with the provisions of Section 242 of the DGCL.


THIRD: That except as amended hereby, the provisions of the Certificate of Incorporation, shall remain in full force and effect.
