ASSIGNOR does hereby authorize and request the Patent Office Officials in the United States and its territorial possessions, and in any and all foreign countries, to issue, when granted, any and all Letters Patents thereon, and reissues thereof, to said *ASSIGNEE* as the assignee of the entire right, title and interest in and to the same, for the sole use and behalf of said *ASSIGNEE* and said *ASSIGNEE*'s successors and assigns, to the full end of the term for which said Letters Patents may be granted, as fully and entirely as the same would have been held by *ASSIGNOR* had this assignment and sale not been made; and




