

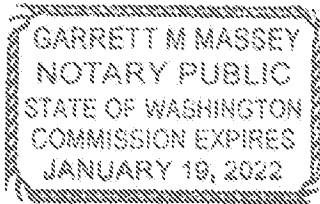
(3) ASSIGNOR certifies that the person signing this assignment is a lawful representative of ASSIGNOR and is authorized to execute this assignment its behalf.


