Said transfer and assignment from OSRAM Edison-Clerici S.p.A. to OSRAM GmbH is further acknowledged to be valid and in full effect with respect to any heirs, successors, assigns, or other legal representatives to have the full and entire right, title, and interest in and to The Invention and The Property.

OSRAM GmbH acknowledges receipt of The Property from OSRAM Edison-Clerici S.p.A..




