PATENT RELEASE AND REASSIGNMENT

THIS PATENT RELEASE AND REASSIGNMENT is made as of September 3, 2021, by BANK OF MONTREAL (“Agent”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Patent Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, ALLIED 100, LLC (“Grantor”) and Agent were parties to that certain Patent Security Agreement dated as of March 31, 2017 (the “Patent Security Agreement”) pursuant to which Grantor granted to Agent for the benefit of the Secured Parties, a Lien on and security interest in certain Patents and Patent Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including the Patents set forth on Schedule I hereto;

(i) all of Grantor’s Patents and all IP Licenses providing for the grant by or to such Grantor of any right under any Patent, including, without limitation, those referred to on Schedule I hereto;

(ii) all reissues, reexaminations, continuations, continuations-in-part, divisionals, renewals and extensions of the foregoing; and

(iii) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.


