CONFIRMATORY ASSIGNMENT

This Confirmatory Patent Assignment (this "Assignment") is entered into as of the last date noted below, by and between **Charles L. Bush, Jr.**, having an address of 7 Jefferson Place, Wayne, New Jersey, 07470 ("Assignor") and **Stryker European Operations Holdings LLC** a Limited Liability Company of Delaware, having an address of 2825 Airview Boulevard, Kalamazoo, Michigan 49002 ("Assignee"). Assignor and Assignee are collectively referred to as the "Parties" and individually as a "Party."

WHEREAS, an assignment dated June 12, 2019 ("the Prior Assignment") assigning various rights, including U.S. Patent Application No. 16/327, 672 filed on February 22, 2019 and the inventions therein (collectively the "Patent Rights"), incorrectly listed Stryker European Holdings I, LLC, a Limited Liability Company of Delaware, having an address of 2825 Airview Boulevard, Kalamazoo, Michigan 49002, ("SEH I") as assignee.

NOW, THEREFORE, with acknowledgement by the Parties of the receipt and exchange of valuable and sufficient consideration associated with the Prior Agreement, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

1. To correct the foregoing error, *nunc pro tunc*, as of February 22, 2019, Assignor hereby assigns all right, title and interest in the Patent Rights to Assignee, and Assignee hereby accepts, the entire right, title and interest, for the United States of America and all other countries, in and to the Patent Rights, to have and to hold the same, unto Assignee for its own use and enjoyment and for the use and enjoyment of its successors and assigns, for the full term or terms of all such rights. The assignment of the Patent Rights shall include the right to file patent applications under the laws of the United States and all other countries that claim the benefit of any of the Patent Rights, in the name of the Assignee or its affiliates, wherever such right may be legally exercised, and all rights under any International Conventions for the Protection of Industrial Property, including the Paris Convention and the European Patent Convention and the corresponding rights to claim benefit from the priority of such applications.

2. Assignor hereby authorizes and requests the United States Commissioner of Patents, and the Patent Office officials in foreign countries as are duly authorized by the respective

foreign patent laws to issue patents, to issue any and all patents within the Patent Rights to the Assignee as the owner thereof.

3. Assignor hereby agrees, without further consideration and without expense to the Assignor, to sign all documents and to perform all other lawful acts which the Assignee may reasonably request to make this Assignment of the Patent Rights fully effective. Assignor hereby also declares that Assignee may take any steps for recordal of this Assignment in the sole name of the Assignee.

4. This Assignment shall be binding upon, inure to the benefit of, and be enforceable by, the Parties and their respective successors and permitted assigns.

5. This Assignment shall be governed by, and construed in accordance with the laws of the State of New Jersey, U.S.A.

6. This Assignment may be executed and delivered (including electronically) in one or more counterparts, and by the Parties in separate counterparts, each of which when executed shall be deemed to be an original, but when taken together shall constitute one and the same agreement.
