**TERMINATION AND RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), dated as of September 21, 2021, is made by KIAN MEZZANINE PARTNERS II, L.P., a Delaware limited partnership, as the administrative agent and collateral agent for the Lenders ("Agent"), under that certain Patent Security Agreement, dated as of March 23, 2018, by THE RETROFIT SOURCE, LLC, a Delaware limited liability company ("Retrofit"), and MORIMOTO LIGHTING LLC, a Delaware limited liability company (as successor by conversion to MORIMOTO LIGHTING LLC, a Georgia limited liability company, "Morimoto," and together with Retrofit, individually and collectively, "Grantor"), in favor of Agent (as amended, supplemented or modified and in effect from time to time, collectively, the "IP Security Agreement"). Capitalized terms used but not defined herein shall have the meanings set forth in the IP Security Agreement.

WHEREAS, pursuant to the IP Security Agreement, Grantor granted a security interest to Agent (for benefit of the Lenders) in certain intellectual property collateral, including the Patent Collateral set forth on Schedule I thereto; and

WHEREAS, an executed copy of the IP Security Agreement was recorded with the Patent Assignment Recordation Branch of the United States Patent and Trademark Office on March 26, 2018 at Reel 045352, Frame 0476; and

WHEREAS, Agent has agreed to terminate, release and discharge its security interest in all of such Patent Collateral, including, without limitation, the Patent Collateral identified on Schedule I attached hereto, being the same Patent Collateral set forth on Schedule I to the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, irrevocably and unconditionally (a) terminate and cancel the liens and security interest created under the IP Security Agreement in the Patent Collateral, (b) release its security interest in the Patent Collateral, and (c) discharge any and all rights, title and interest it has in the security interest granted to Agent in the Patent Collateral; in each case, the Patent Collateral shall include, without limitation, the Patent Collateral set forth on Exhibit A.

Agent agrees to take all further actions, and provide to the Grantors and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
