ASSIGNMENT

WHEREAS, I, **David Joseph Alter**, a citizen of the United States, residing at 392 Kentucky Blue Circle, Apopka, Florida, USA 32712 (herein "**Mr. Alter**"), have invented certain new and useful improvements in:

- I. **Bullet-Proof Backpack** for which I have executed an application for Letters Patent of the United States, Application Serial Number 16/600,804, filed on October 14, 2019 and for which I have been granted an issued Patent of the United States, Patent Number 11,022,405, issued on June 1, 2021 (herein the "**Bullet-Proof Backpack Patent**"), and
- II. **Trailer-In-Tow Warning System For A Towing Vehicle** for which I have executed an application for Letters Patent of the United States, Application Serial Number 16/714,148, filed on December 13, 2019 and for which I have been granted an issued Patent of the United States, Patent Number 10,857,935, issued on December 8, 2020, (herein the "**Trailer-In-Tow Patent**" and wherein together the **Bullet-Proof Backpack Patent** and the **Trailer-In-Tow Patent** are referred to collectively herein as the "**Alter Patents**");

WHEREAS, I, **Mr. Alter**, am desirous of assigning the entire right, title and interest in, to and under said improvements and said issued **Alter Patents** to the **David Joseph Alter Revocable Trust** (herein the "**Alter Revocable Trust**") having a date of July 26, 2021 of which I, **Mr. Alter**, am the grantor and trustee;

NOW, THEREFORE, I, **Mr. Alter**, do hereby assign, transfer and set over to said **Alter Revocable Trust**, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the said improvements, and the said issued **Alter Patents**, including the right to claim priority to said **Alter Patents**, and all divisions, continuations and continuations-in-part thereof, and all Letters Patent which may be granted thereon and all reexaminations, reissues, renewals and extensions thereof, and all applications for Letters Patent which may hereafter be filed for said improvements in any country or countries foreign to the United States,

and all Letters Patent which may be granted for said improvements in any country or countries foreign to the United States and all reexaminations, reissues, renewals and extensions thereof; and I hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvements to the said **Alter Revocable Trust**, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.

AND I HEREBY further covenant and agree that I and my heirs, representatives and successors, if any, will communicate to the said **Alter Revocable Trust**, its successors, legal representatives and assigns, any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said **Alter Revocable Trust**, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.

AND I HEREBY grant Heslin Rothenberg Farley & Mesiti P.C. the power to insert on this assignment any further indication which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.


