PLAN OF CONVERSION

This Plan of Conversion (this "**Plan**") is made and adopted effective as of January 14, 2021 to convert Light Steering Technologies, LLC, a New Hampshire limited liability company (the "**NH LLC**"), into Light Steering Technologies, Inc., a Delaware corporation (the "**Corporation**").

RECITALS

A. The NH LLC was formed under the name Light Steering Technologies, LLC, by the filing of Certificate of Formation with the Secretary of State of the State of New Hampshire on January 31, 2019 (the "**NH Certificate**").

B. A conversion of a New Hampshire limited liability company into a Delaware corporation may be made pursuant to the NH and DE statutes.

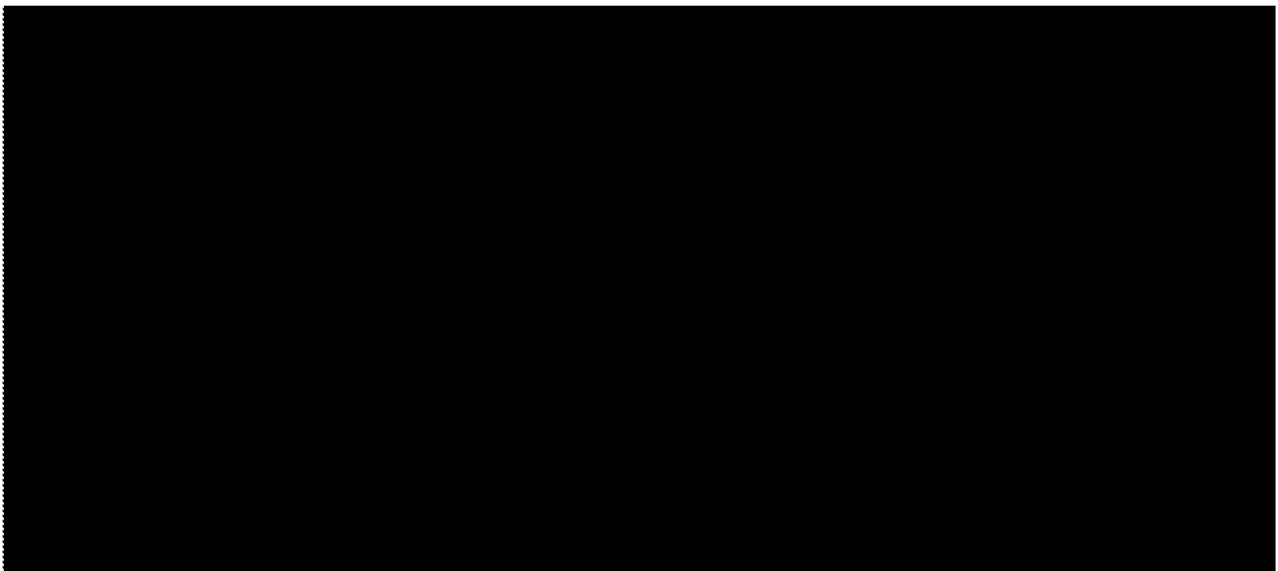
C. The Members of the NH LLC (each a "**Member**" and together the "**Board**") have determined it to be in the best interests of the NH LLC that the Company be converted from a New Hampshire limited liability company into a Delaware corporation (the "**Conversion**").

AGREEMENT

NOW, THEREFORE, the NH LLC does hereby adopt this Plan to effectuate the Conversion as follows:

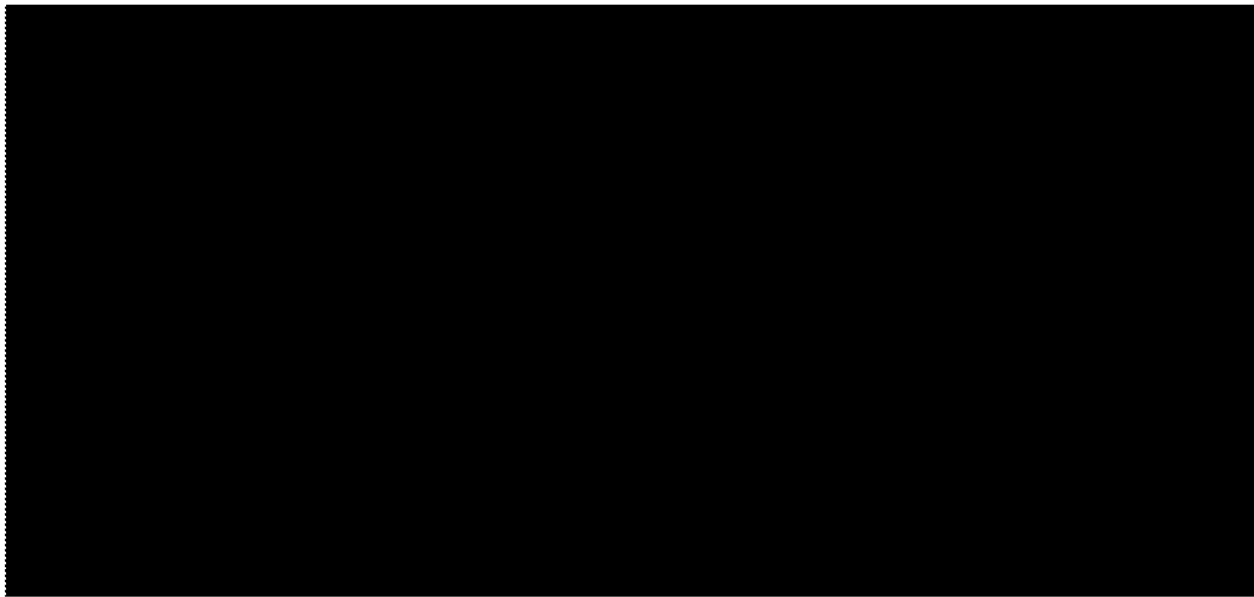
1. **Recitals.** The Recitals set forth above are hereby incorporated into and shall constitute a part of this Plan.

2. **Approval; Conversion.** The Members have approved the Conversion in accordance with the terms of this Plan and applicable law. On the Effective Date (*defined below*), the NH LLC shall convert into the Corporation.



6. **Effect of Conversion.** Upon the Effective Date, the Corporation shall for all purposes be deemed to be the same entity as the NH LLC. All of the rights, privileges and powers of the NH LLC, and all assets and property (real, personal and mixed) and all debts due to the NH LLC, as well as all other things and causes of action belonging to the NH LLC, shall remain vested in the Corporation and shall be the property of the Corporation and the title to any real property vested by deed or otherwise in the NH LLC shall not revert or be in any way impaired by reason of the Conversion. All rights of creditors and all liens upon any property of the NH LLC shall be preserved unimpaired, and all debts, liabilities and duties of the NH LLC shall remain attached to the Corporation, and may be enforced against it to the same extent as if said debts, liabilities and duties had originally been incurred or contracted by the Corporation. The rights, privileges, powers and interests in property of the NH LLC, as well as the debts, liabilities and duties of the NH LLC, shall not be deemed, as a consequence of the Conversion, to have been transferred to the Corporation for any

purposes of the laws of the States of New Hampshire and Delaware.

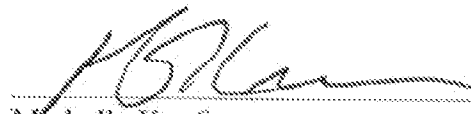

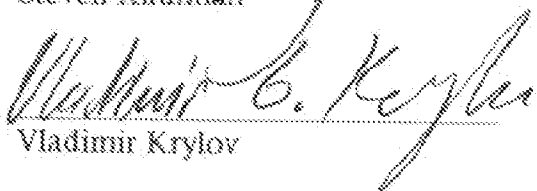

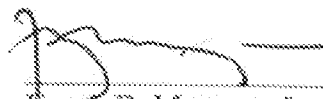
